**D. Critical Incident Stress Management, 2 hours.**  
**AZPOST Instructor: TBA**

This training course is designed to present the core elements of a comprehensive, systematic approach to crisis intervention. The course prepares participants to provide a wide range of crisis intervention services to include pre and post incident crisis education, spousal/significant other support, on-scene support, crisis intervention for individuals, mobilization and demobilization after traumatic events and small group defusing. The need for appropriate follow-up, professional referrals and peer limitations is also discussed.

**E. What You Do Matters, 3.5 hours. AZPOST Instructor: TBA,**

“What You Do Matters” examines policing within the legal and political framework of Nazi Germany, a journey that eventually turned those who should protect life and liberty into those who intimidated, humiliated, deported, and eventually murdered millions of innocent people? Using historical images and stories from the Holocaust, the course utilizes trained facilitators to engage students in a dialogue about the role of law enforcement in today’s communities and the importance of core values in ensuring the integrity and vibrancy of democracy.

**F. Civil Service Update, .5 hour AZPOST Instructor: TBA,**

This class will provide all the legal updates involving the service of civil and criminal documents in the State of Arizona. It will also discuss pending legislative actions that may also affect the service of these documents during the current legislative session.

**G. Generations, 4 hours. Instructors: AZPOST Instructor: TBA.**

Participants will gain an understanding of the different needs, attitudes, and approaches to life between today’s four generations- Matures, Baby Boomers, Generation X, and Millennial. Learn why typical approaches no longer work with the four generations and how stereotyping hinders communication and understand the most common generational sticking points and discuss solutions.
