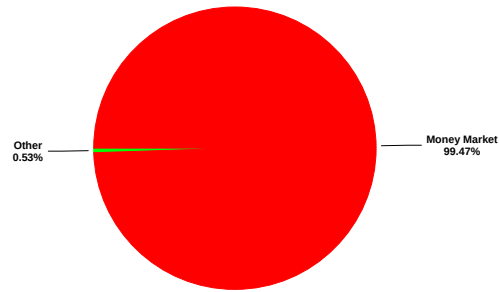

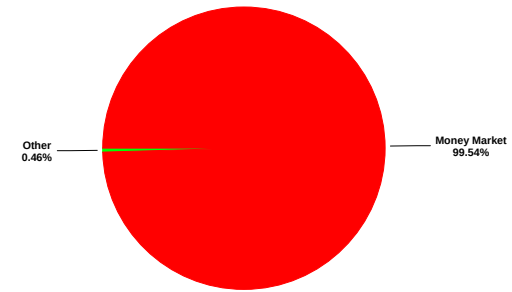

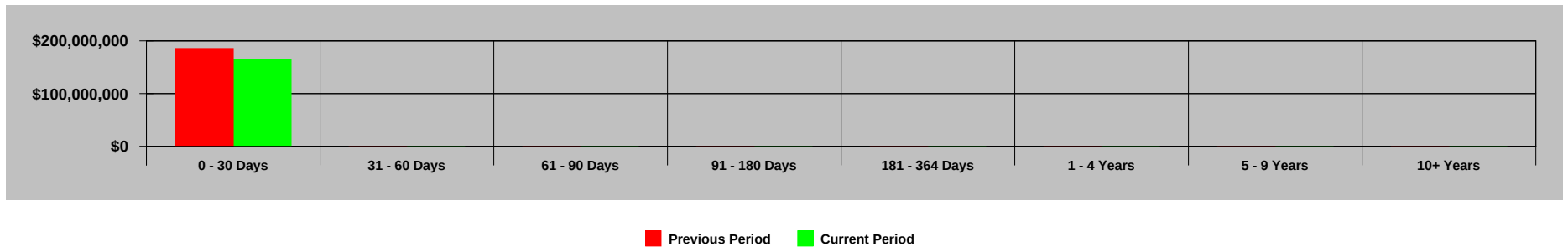
Portfolio Composition - 09/30/14



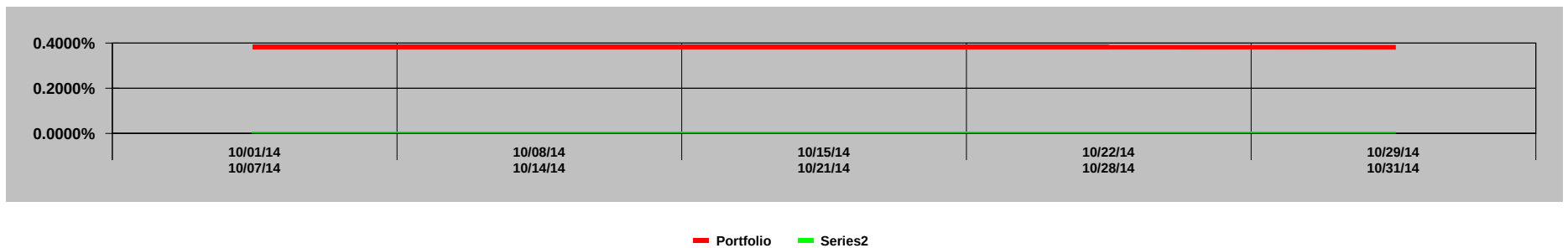
Portfolio Composition - 10/31/14

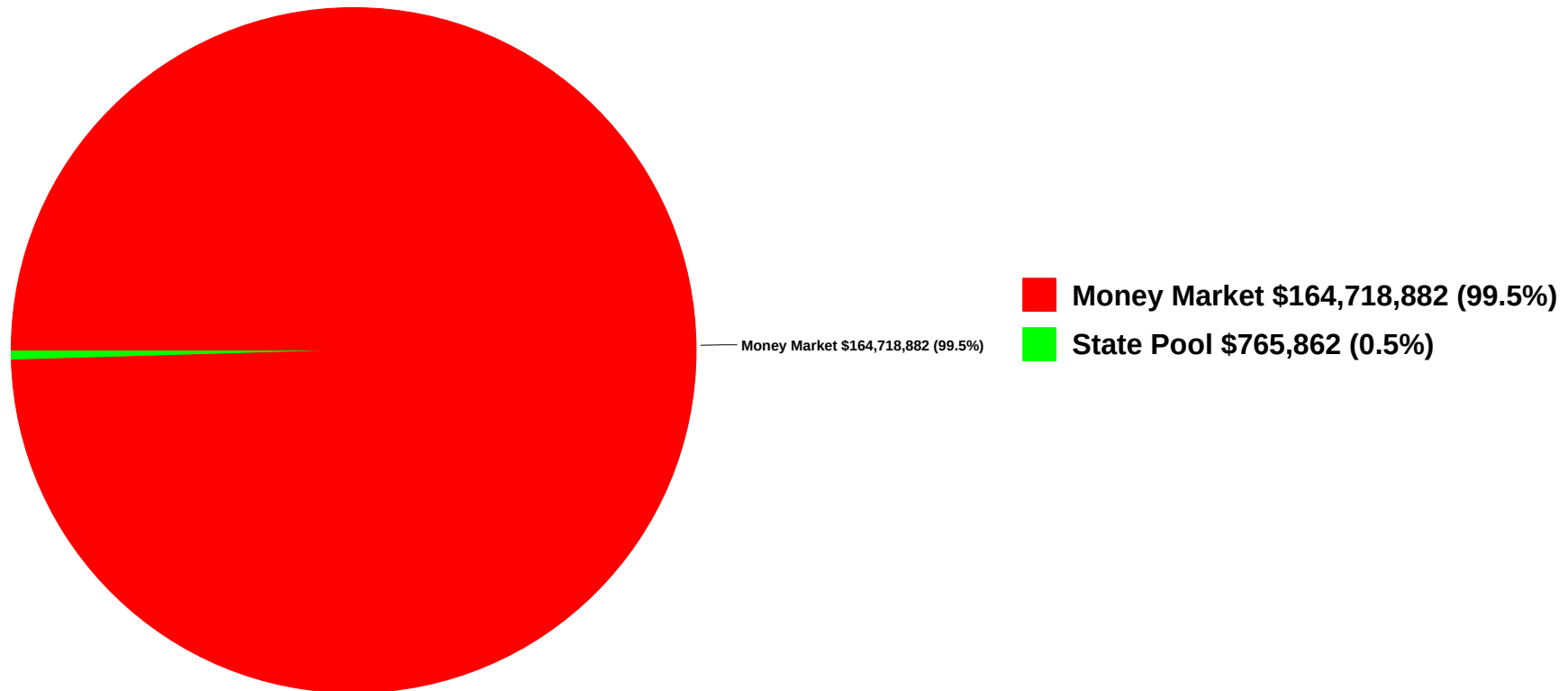

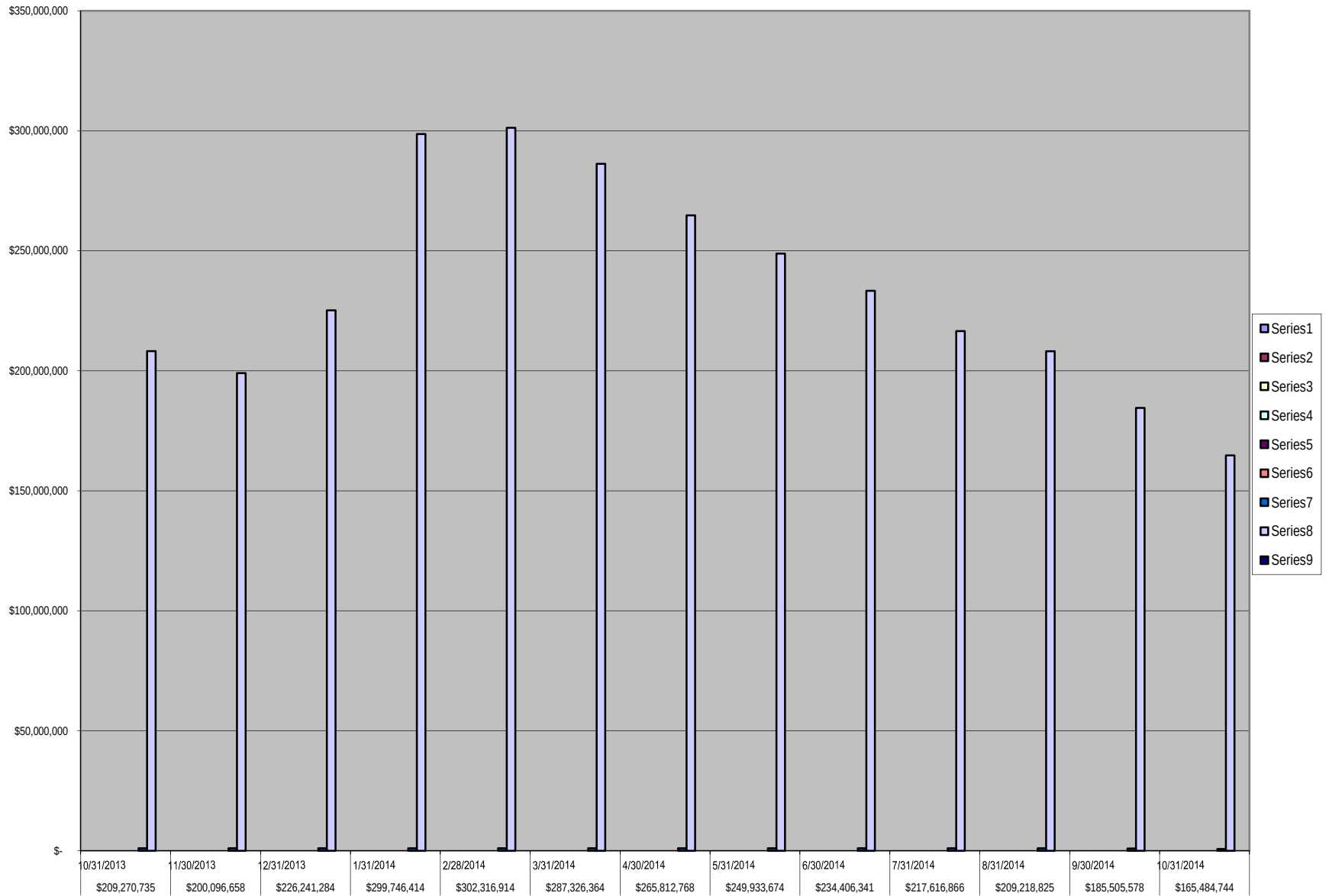

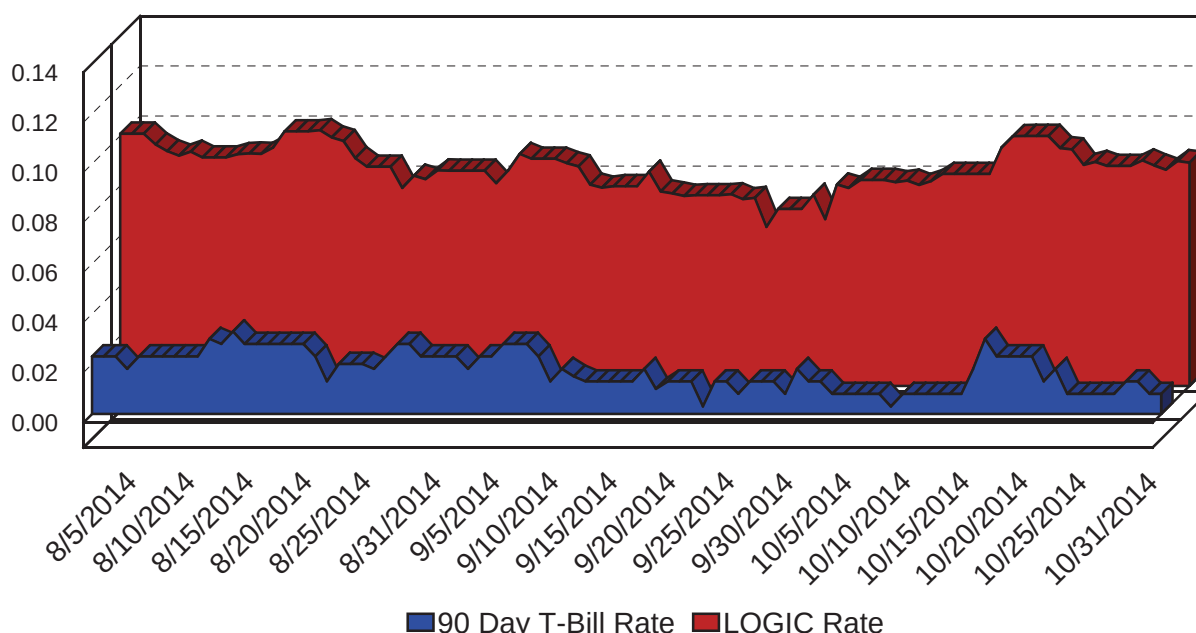
