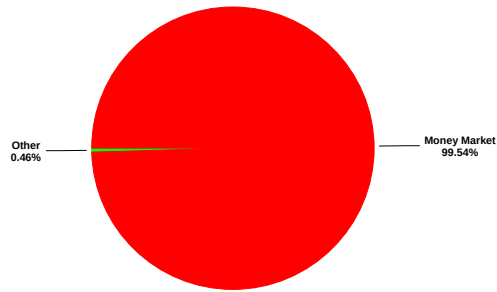

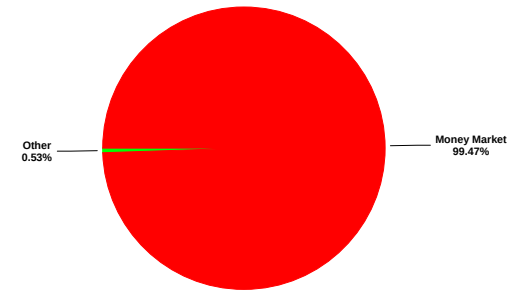

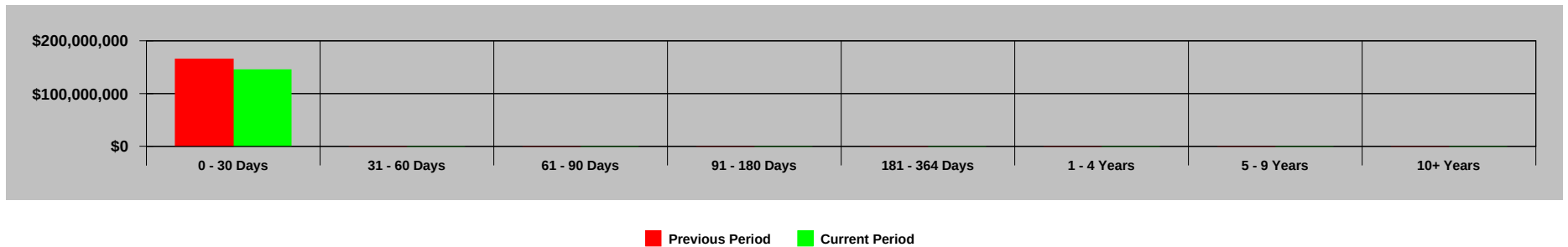
Portfolio Composition - 10/31/14



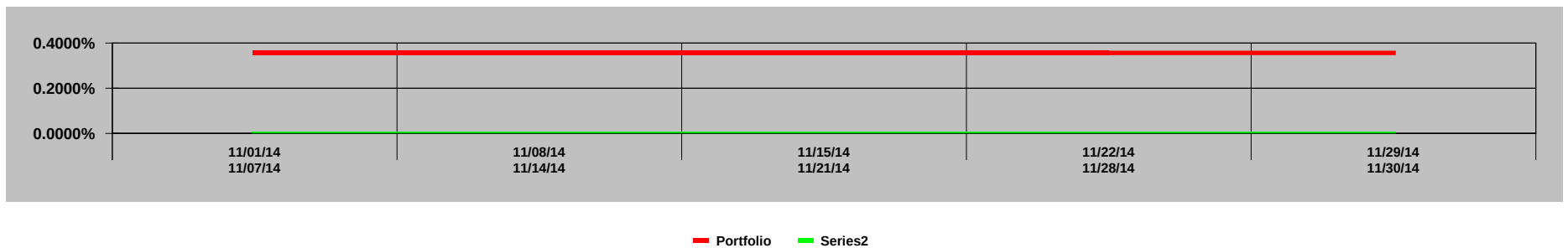
Portfolio Composition - 11/30/14

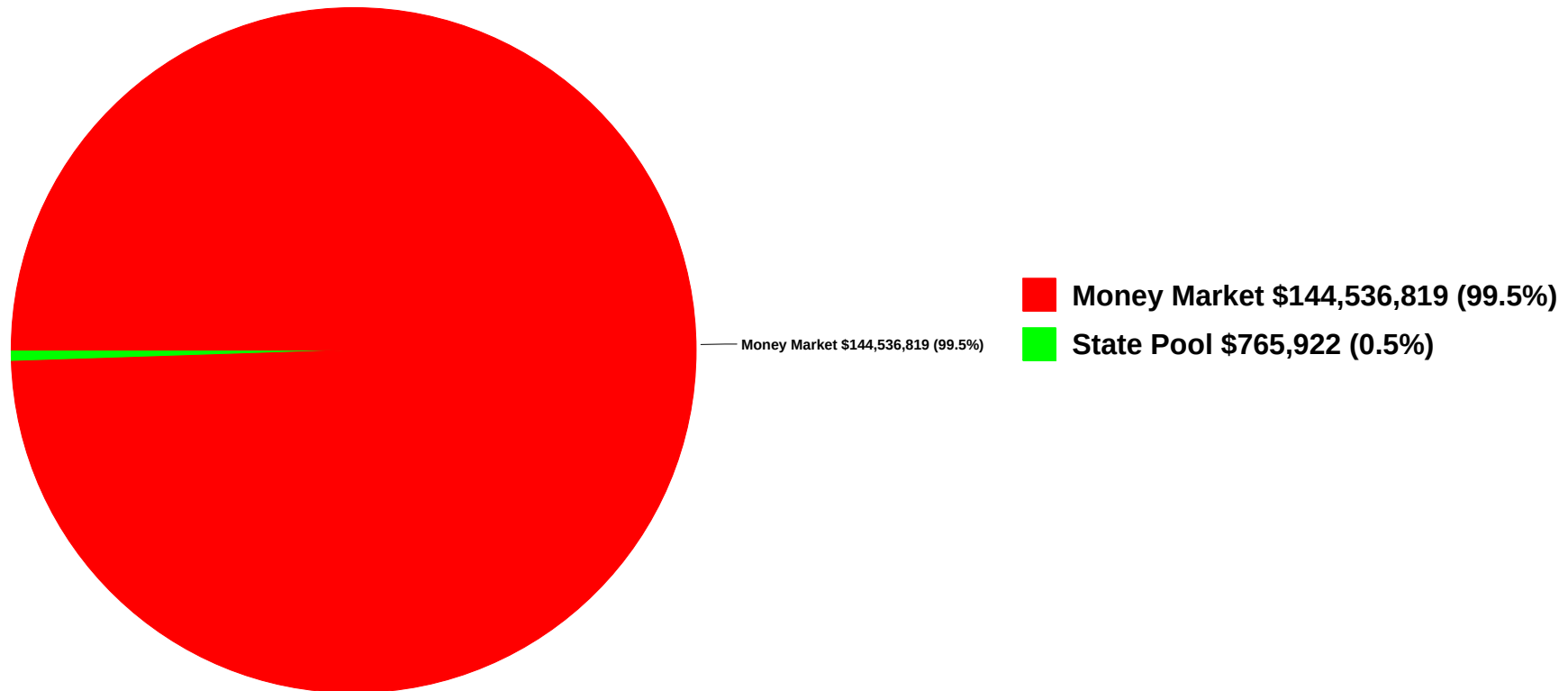

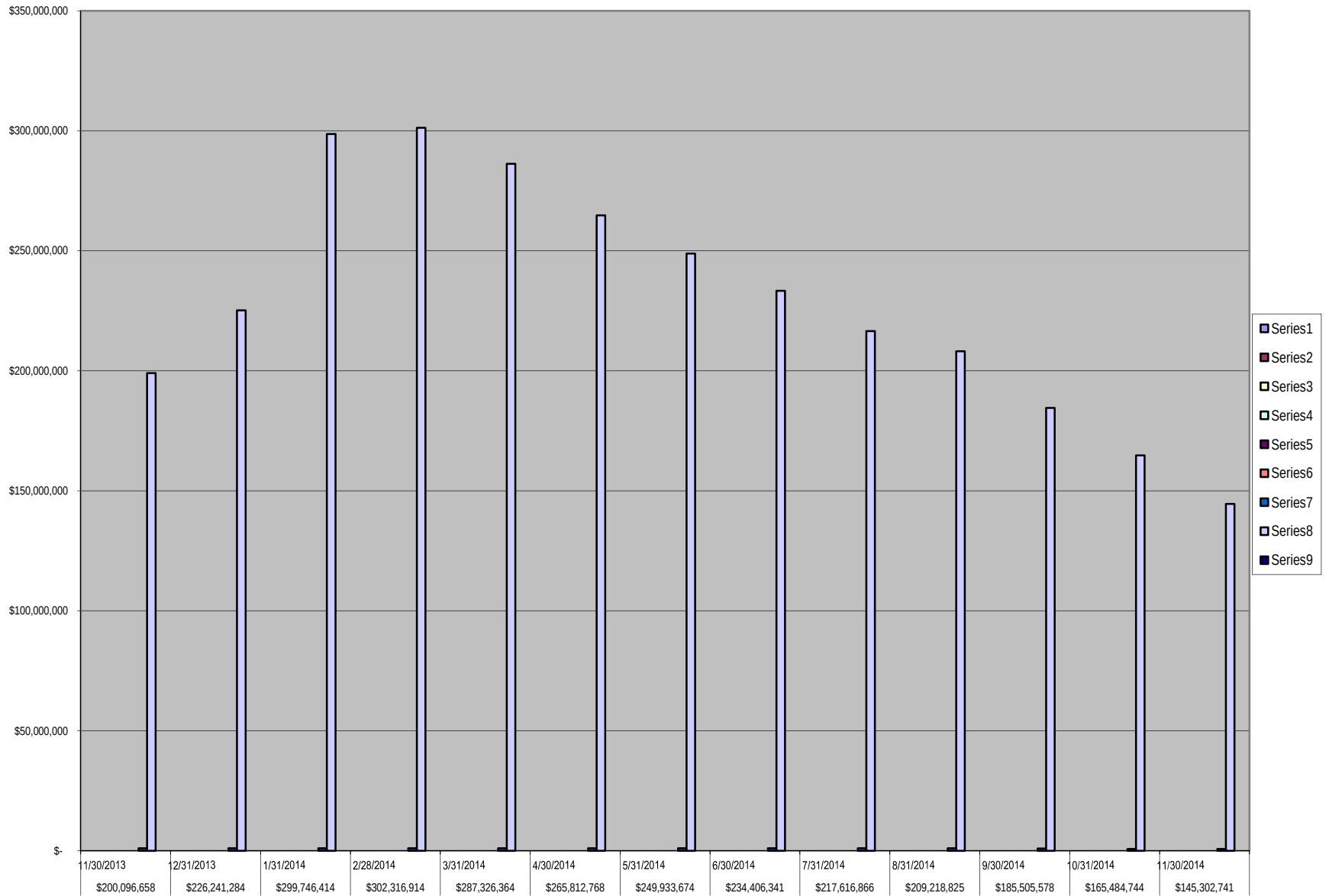

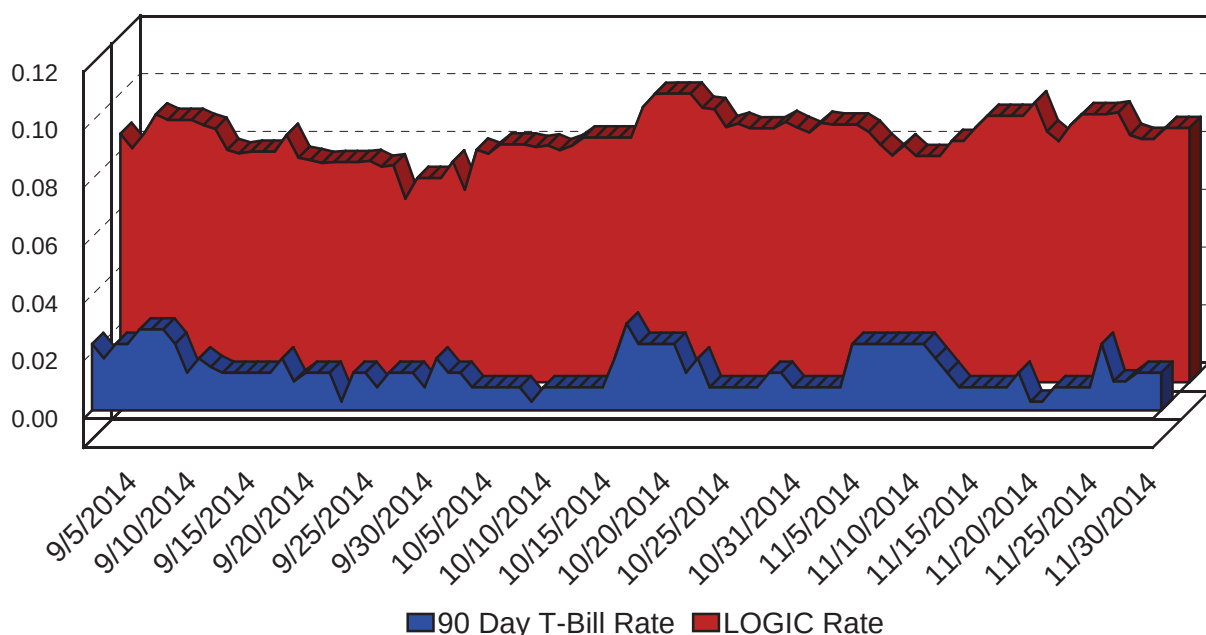
