03-17-2015 - YRM: Requesting revision for a zero-dollar changed which allows FBC to move the remaining \$466,520 in federal funds left after completion of SH 36 P&R to construction of Westpark P&R. Preliminary work for Westpark P&R was funded by TX 04-0041 and the construction is funded by TX 95-x080 (\$2.5 CMAQ). As with the SH 36 Park and Ride project, FTA has approved the value of land donation as in-kind local match for Westpark Park and Ride project. Documentation is attached. Because the federal (CMAQ) funds in the existing grant are beyond their period of availability (lapsed), FBC is requesting FTA approval of a zero-dollar amendment beyond the period of availability. The MPO (HGAC) and TxDOT have concurred to this use of these lapsed CMAQ funds.

Fort Bend County seeks to use CMAQ funds in the amount of \$1,495,810 to construct SH 36 Park and Ride. Donated land valued at \$565,000 will be used in lieu of local cash match. Other sources of funding for this project include Urban ARRA (TX-96-x034, Rural ARRA (TX-86-x001), and Urban 5307 (TX-90-x836).
