

MENTAL HEALTH PUBLIC DEFENDER ADVISORY BOARD

Fort Bend County Public Defender Advisory Board

August 10, 2015

- I. The current Mental Health Public Defender Advisory Board hereby recommends that it becomes the Fort Bend County Public Defender Advisory Board.

- II. The Fort Bend County Public Defender Advisory Board will consist of: 2 Commissioners, 1 representative from the County Judge's Office, 2 attorneys from the local bar, Director of Behavioral Health Department, 1 representative from TEXANA Board, Mental Health Court Judges, 1 representative Judge from both Misdemeanor and Felony Courts.

- III. Voting members of the Fort Bend County Advisory Board will be the same as the current Mental Health Public Defender Advisory Board: 2 Commissioners, 2 local bar Attorneys, and Director of Behavioral Health Department.

- IV. Non-voting members will be the two Judges of the Mental Health Courts, the 2 Judges representing the Misdemeanor and Felony Courts, a TEXANA Board member, and a representative from the County Judge's Office.

- V. Chair of the Fort Bend County Public Defender Advisory Board will held by a local bar attorney on a yearly rotating basis between the two local bar attorney members of the Advisory Board.


