

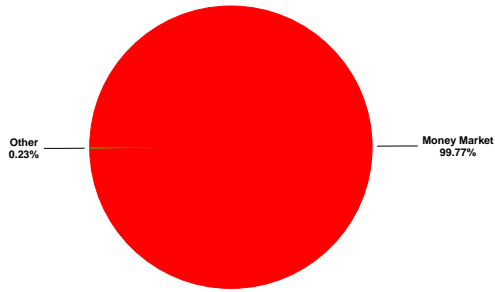

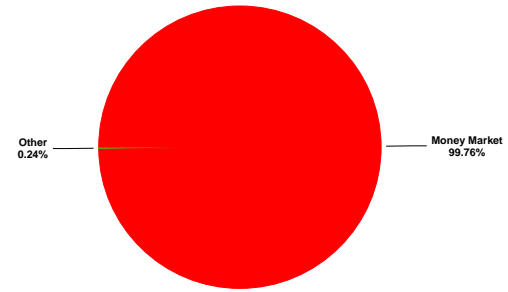

Portfolio Composition - 04/30/15

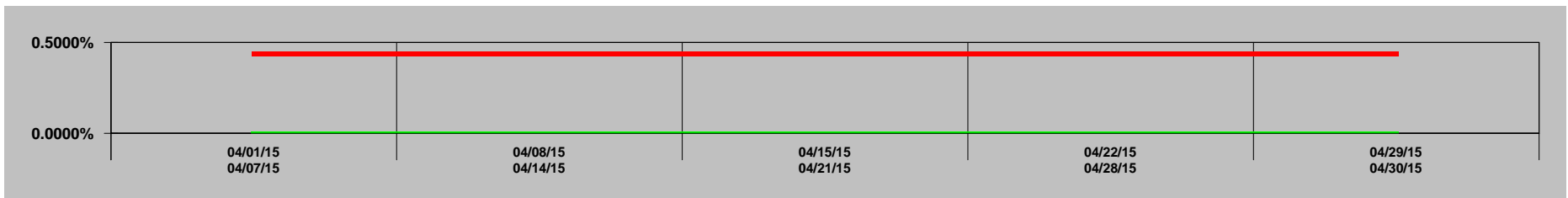


Maturity Aging - 03/31/15 vs 04/30/15



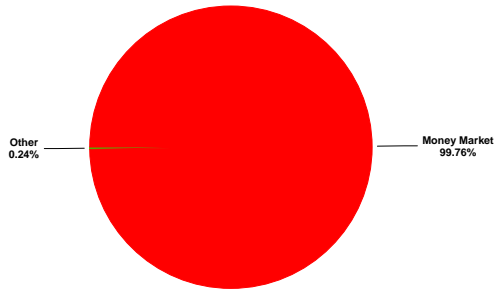

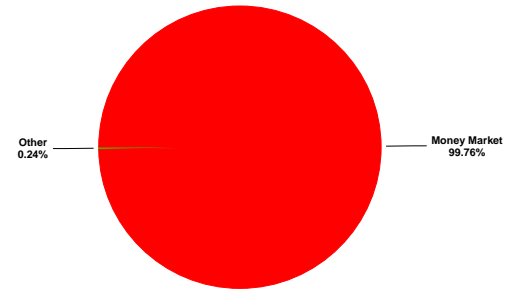

Portfolio Composition - 05/31/15

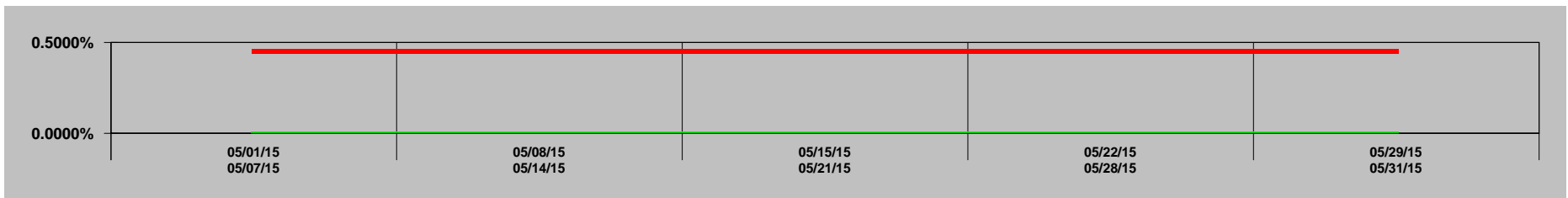


Maturity Aging - 04/30/15 vs 05/31/15

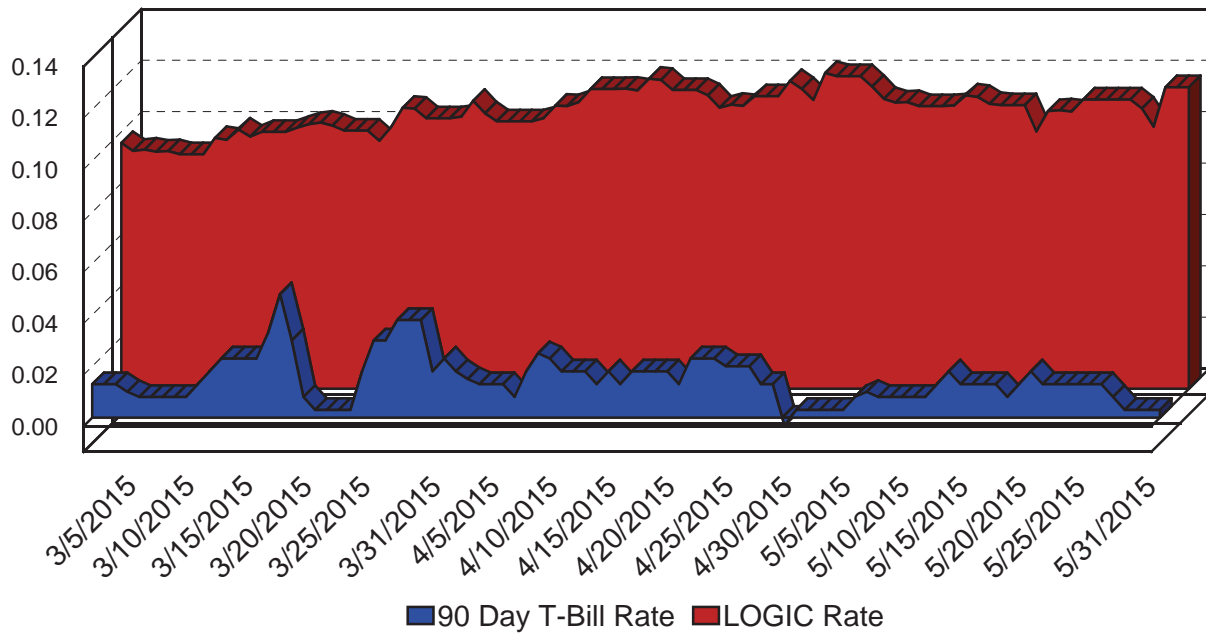

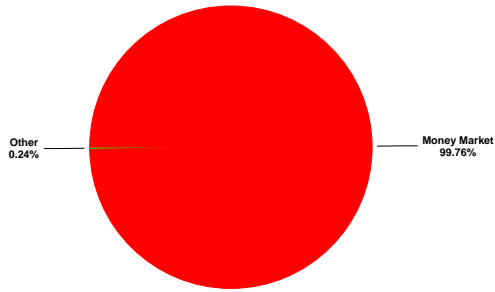

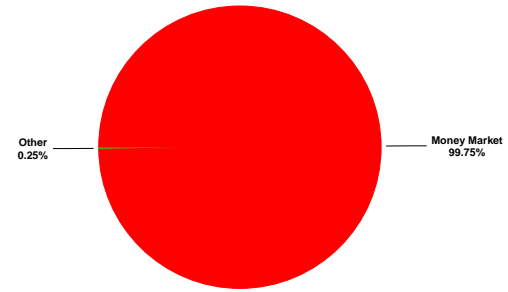

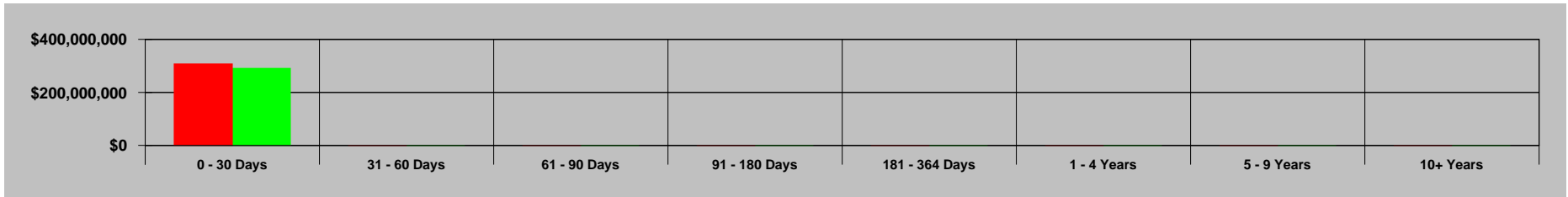
Portfolio Composition - 05/31/15



Portfolio Composition - 06/30/15

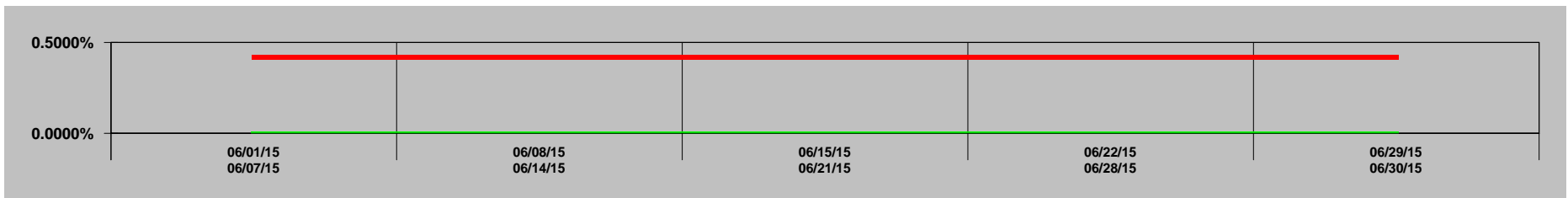


Maturity Aging - 05/31/15 vs 06/30/15

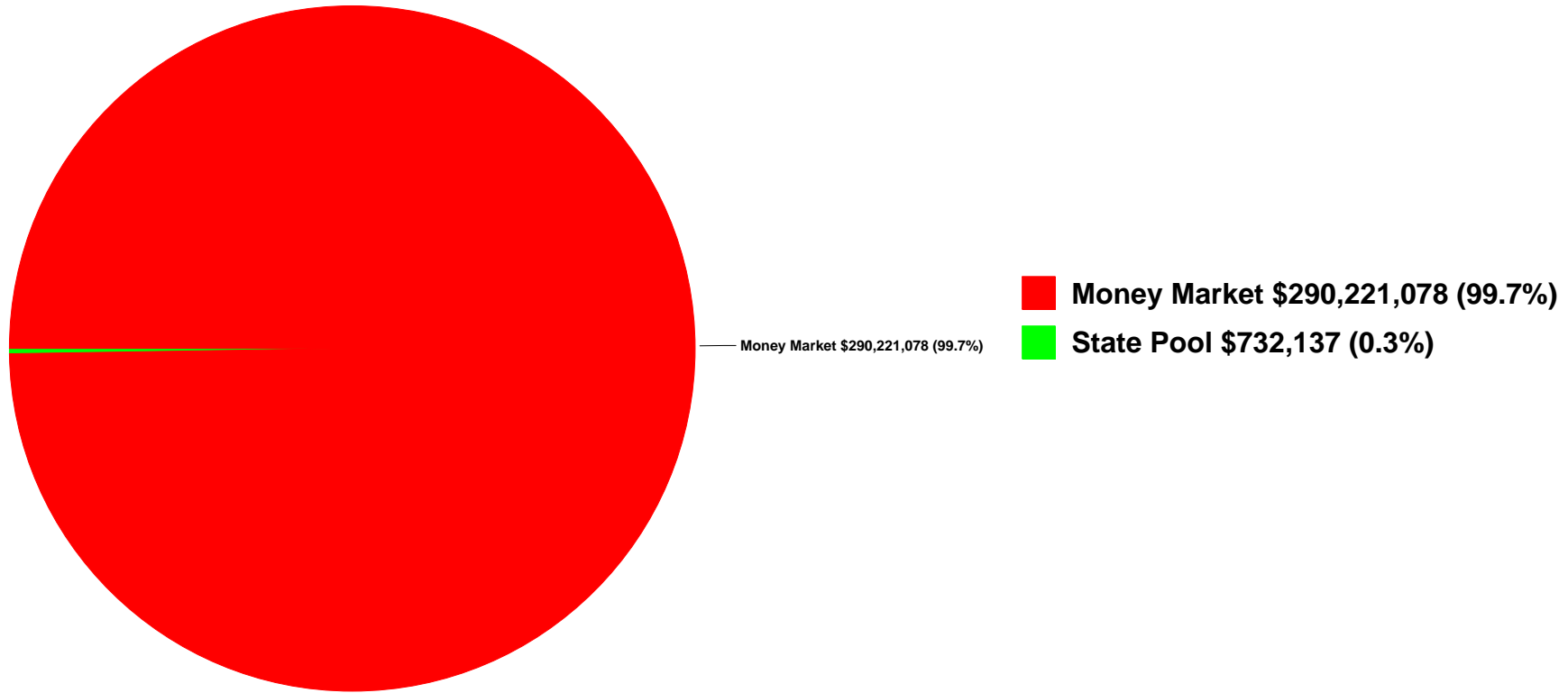

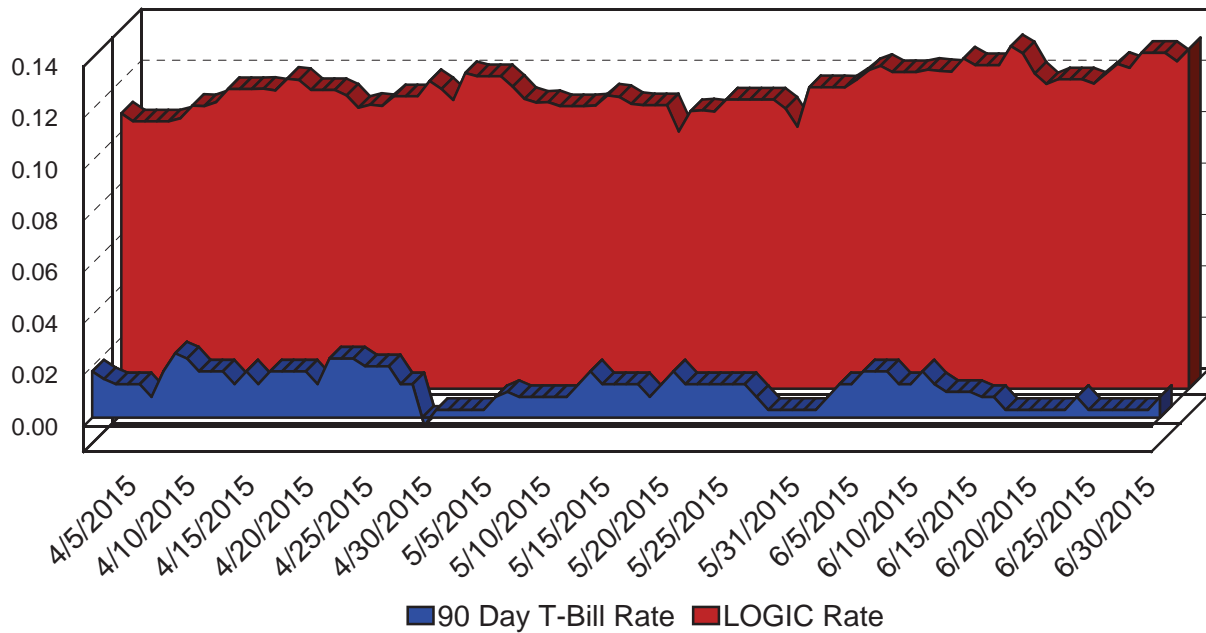
