**ORDER OF FORT BEND COUNTY TO APPOINT THE FOLLOWING MEMBERS TO THE BOARD OF EMERGENCY SERVICES COMMISSIONERS TO SERVE AS THE GOVERNING BODY OF THE NEWLY CREATED FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 7 AS REQUIRED BY SECTION 775.034 AND OTHER RELEVANT PROVISIONS OF CHAPTER 775, TEXAS HEALTH & SAFETY CODE.**

WHEREAS, each of the appointed board members is a resident of the state, and a qualified voter within areas served by the district or the owner of land subject to taxation in the district; and

WHEREAS, each of the appointed board members are appointed to serve until January 1<sup>st</sup>, 2017;

THEREFORE, BE IT ORDERED, ADJUDGED, AND DECREED BY THE COMMISSIONERS COURT OF FORT BEND COUNTY, TEXAS THAT THE FOLLOWING INDIVIDUALS ARE APPOINTED TO THE BOARD OF EMERGENCY SERVICES COMMISSIONERS TO SERVE AS THE GOVERNING BODY OF THE NEWLY CREATED EMERGENCY SERVICES DISTRICT NO. 7 AS REQUIRED BY SECTION 775.034 AND OTHER RELEVANT PROVISIONS OF CHAPTER 775, TEXAS HEALTH & SAFETY CODE UNTIL JANUARY 1, 2017:
