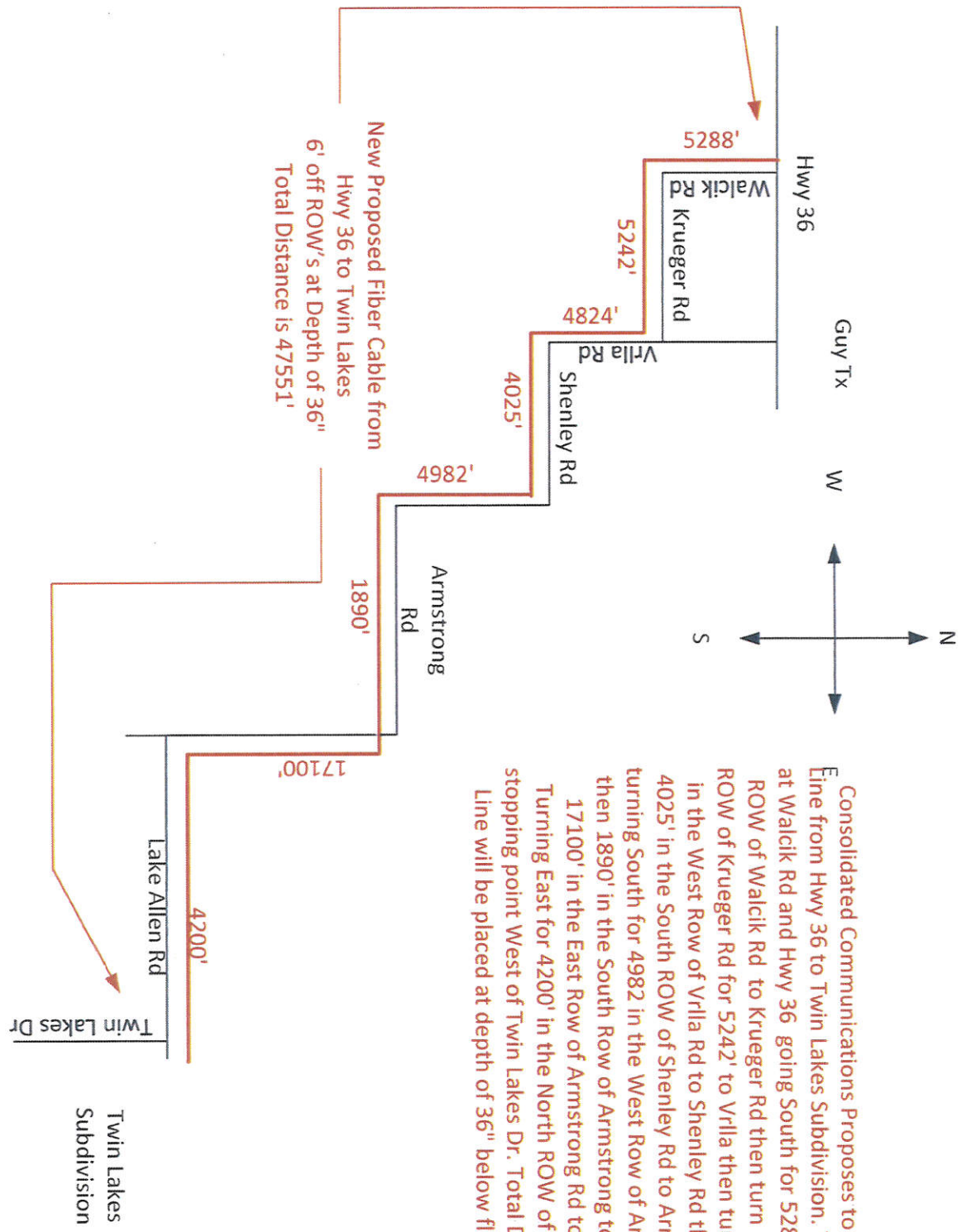

Total Distance is 47551'

Consolidated Communications Proposes to place new Fiber Line from Hwy 36 to Twin Lakes Subdivision. The line will begin at Walcik Rd and Hwy 36 going South for 5288' 6' off the West ROW of Walcik Rd to Krueger Rd then turn East in the South ROW of Krueger Rd for 5242' to Vrla then turn South for 4824' in the West Row of Vrla Rd to Shenley Rd then turn East for 4025' in the South ROW of Shenley Rd to Armstrong Rd. Then turning South for 4982' in the West Row of Armstrong to curve then 1890' in the South Row of Armstrong to next curve then 17100' in the East Row of Armstrong Rd to Lake Allen Rd. Turning East for 4200' in the North ROW of Lake Allen Rd to stopping point West of Twin Lakes Dr. Total Distance is 47551'. Line will be placed at depth of 36" below flow line of ditch.
