The Tax Office is requesting approval to pay replacement fees totaling \$75 for seven money orders that were lost at the Tax Office. The money orders were accepted by Linebarger Goggan Blair & Sampson, LLP as payments on a property tax payment plan. After Linebarger Law Firm presented the money orders to the Tax Office for posting to the taxpayer's account, they were lost. We have confirmed with the issuing companies that to date the money orders have not been cashed. Kroger will charge a fee of \$15 to replace the money order issued by them. PLS Check Cashers will charge \$10 each for the six money orders they issued.
