

**SUPPLEMENTAL AGREEMENT NO. 1 TO  
CONSTRUCTION INSPECTION SERVICES AGREEMENT  
DATED JANUARY 21, 2015**

**Fort Bend Parkway Toll Road (SH 6 Crossing)**

This Supplemental Agreement is made and entered into this 20th day of April, 2016, and modifies the CONSTRUCTION INSPECTION SERVICES AGREEMENT made with Taylor Construction Management, LLC, dated January 21, 2015 for inspection services for the Fort Bend County Toll Road Authority.

The agreement is hereby modified as follows:

1. The first sentence of Section 2.a is replaced with the following sentence:

“The Maximum Compensation under this contract is \$640,000.00.”

2. The second paragraph of Section 2.a is replaced with the following paragraph:

“Compensation for performance of services within the Scope of Services described in Attachment A shall be in accordance with the billing rates shown in Attachment B. The compensation was increased by \$390,000.00, for the work shown in Attachment A. The maximum amount payable under this agreement shall not exceed \$640,000.00.”

3. The first paragraph of Section 3 is replaced with the following paragraph:

“It is understood and agreed that the time for performance of the Engineer’s services under this Agreement shall begin with receipt of the Notice to proceed and end April 30, 2017.”

This Supplemental Agreement does not alter, modify, or otherwise change any part of the Agreement, except as specifically stated in this Supplemental Agreement.

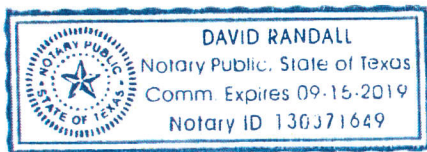
