WHEREAS, the Commissioners Court of Fort Bend County, Texas, desires to reappoint Glen R. Gill and Andre D. McDonald to serve as Directors for the District for the lawful four-year term of office expiring July 2, 2020 or until their successors shall be appointed and qualified; and

WHEREAS, Chapter 57 of the Texas Water Code, as amended, confers jurisdiction on the County Judge and Commissioners Court of Fort Bend County, Texas to appoint the Directors of the District;

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the County Judge and Commissioners Court of Fort Bend County, Texas:

Section 1: That the foregoing recitals be and the same are hereby found to be true and correct.
