


**REVIEW BY FORT BEND COUNTY COMMISSIONERS COURT**

  - a. 48 hours in advance of construction start up, and
  - b. when construction is completed and ready for final inspection

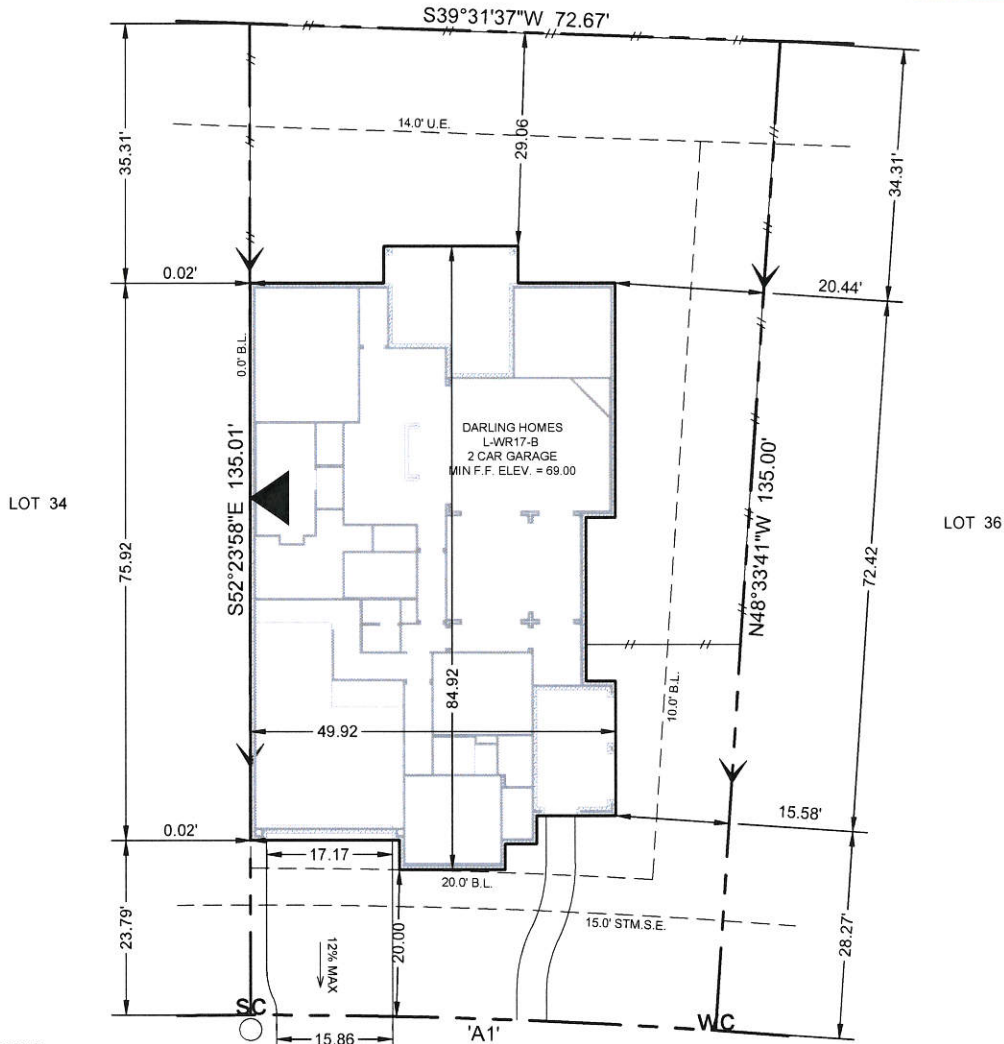
