BY VIRTUE OF SUCH FAILURE, BENEFICIARY IS ENTITLED TO RECEIVE FUNDS IN THE AMOUNT OF USD(INSERT AMOUNT)."

B. "THE UNDERSIGNED, FORT BEND COUNTY JUDGE ROBERT E. HEBERT, OR HIS SUCCESSORS IN OFFICE, HEREBY CERTIFIES TO AMEGY BANK, AS THE ISSUER OF LETTER OF CREDIT NO. SBPTX301661, DATED JULY 21, 2016 IN THE AMOUNT OF FIFTY THOUSAND AND 00/100 U.S. DOLLARS (USD50,000.00), THAT AMEGY BANK HAS DELIVERED NOTICE OF INTENT TO NOT AUTOMATICALLY RENEW LETTER OF CREDIT NO. IT IS THE CONDITION OF THIS LETTER OF CREDIT THAT IT SHALL BE AUTOMATICALLY RENEWED FOR A PERIOD OF NO LESS THAN ONE YEAR FROM THE PRESENT OR EACH FUTURE EXPIRATION DATE, UNLESS AT LEAST THIRTY (30) DAYS PRIOR TO SUCH DATE, WE, AMEGY BANK (THE ISSUER), SHALL NOTIFY FORT BEND COUNTY JUDGE ROBERT E. HEBERT, OR HIS SUCCESSORS IN OFFICE, IN WRITING BY COURIER, THAT WE ELECT NOT TO RENEW THIS LETTER OF CREDIT FOR SUCH ADDITIONAL PERIODS.

NOTWITHSTANDING ANY REFERENCE IN THIS LETTER OF CREDIT TO OTHER DOCUMENTS, INSTRUMENTS OR AGREEMENTS, OR REFERENCES IN SUCH OTHER DOCUMENTS, INSTRUMENTS OR AGREEMENTS TO THIS LETTER OF CREDIT, THIS LETTER OF CREDIT CONTAINS THE ENTIRE AGREEMENT AMONG THE ACCOUNT PARTY (APPLICANT), BENEFICIARY AND THE ISSUER HEREUNDER RELATING TO THE OBLIGATIONS OF THE ISSUER HEREUNDER.
