AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and S&B Infrastructure, Ltd., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on December 1, 2015, (hereinafter "Agreement") pursuant to SOQ 14-025; and

WHEREAS, the parties desire to amend the Agreement to include additional professional engineering services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. Services to be rendered under the Agreement shall be amended to add additional services, as described in the Supplemental Engineering Proposal, attached hereto as Exhibit A, and incorporated herein for purposes.
2. County shall pay Contractor an additional thirty-two thousand seventy-eight dollars and 60/100 (\$32,078.60), for the additional professional engineering services to be rendered under this Amendment.
3. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed three hundred eighty-one thousand three hundred fifty-three dollars and 60/100 (\$381,353.60), allocated as follows:
 - A. \$349,275.00 under the Agreement; and
 - B. \$32,078.60 under this Amendment.
4. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without a written agreement executed by the parties.
5. Any and all references to 2013 Mobility Project No. 13102 under the Agreement shall hereby be changed to reflect 2013 Mobility Project No. 13117x.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

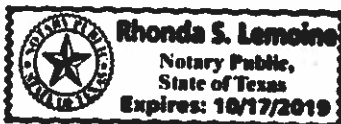
