Notice is hereby given that an election shall be held in the County on the 3rd day of November, 2015, in which all resident, qualified electors of the County shall be entitled to vote for voting in a special election to adopt or reject the proposed Constitutional Amendments as submitted by the 84th Legislature of the State of Texas and for voting approving, or disapproving, public questions submitted by Fort Bend County. The polls shall be open for voting at such election from 7:00 a.m. to 7:00 p.m. Fort Bend County has adopted a countywide polling place program allowing voting at any election day polling location, and the election shall be conducted at each polling place, respectively, by the officers previously appointed by order of the Commissioners Court. The listing of polling places for November 3, 2015 is made a part hereof for all purposes.
