Dear Court Leader,

The National Center for State Courts (NCSC) was founded in 1971 at the urging of the late Chief Justice of the United States Warren E. Burger. For more than 40 years, the NCSC's mission has remained consistent: improving the administration of justice through leadership, research, education, technology and consulting services.

Every other year, the NCSC sponsors an e-Courts conference, which is designed to improve court efficiencies and effectiveness by educating court professionals about the latest breakthroughs and best practices in court technology. This year, **e-Courts is being held in Las Vegas, Nevada, December 12-14.** We expect the conference to draw more than 500 national and international participants. e-Courts also showcases one of the highest quality court technology exhibit shows available.

e-Courts provides judges, court administrators, court managers, technologists and others, with two and a half days of professional development, education sessions, and networking. Here's how one attendee explained the e-Courts' value:

"This is the most productive conference that I have ever attended. This is probably due to relevance of the sessions to our project and we also see where technology is headed."

NCSC is the only national court organization dedicated to helping the justice system use technology to improve services, reduce costs, and increase accountability. We understand that in order to attend e-Courts 2016, your court professional will need financial support and time away from the office to gain the education, resources and networking necessary to successfully fulfill their duties.

Average costs for e-Courts 2016 include:

- Registration – \$500 through June 30; \$550 July 1 – September 30
- Hotel – hotel rates are \$149 plus tax per night
- Meals & Incidental Expenses – Govt. per diem, Las Vegas \$64 per day (through Sept. 2016)
