> We are hoping to have a tractor purchased, used to assist with our garden projects around our complex, to use for county-
wide demonstration projects, and used at the discretion of Extension staff for work-related needs. The attached quote is based
off of dealer cost with manufacturer discounts. This is by far the best price for the size of equipment we are needing.
> Based off the quoted price attached from Rosenberg Tractor, The Fort Bend County Master Gardeners Association (FBMG)
and the Fort Bend Ag/Hort Advisory Committee (AHAC) have agreed tentatively to purchase the tractor outright. Based off the
quote, the shared cost of $15,327.00 would be as follows:
> 75 percent buy-in by FBMG for a total of $11,495.25
> 25 percent buy-in by AHAC for a total of $3,831.75
> FBMG would utilize their educational non-profit status, so no taxes would be associated with the final price. There is no title
associated with tractors, at least at this size, so no funds necessary for registrations, title, etc.
> Questions that we have wrap around annual maintenance and insurance coverage. In this situation, who would cover annual
maintenance expenses (oil, lubricants, filters, fluids, etc.)? Further, would the County cover this equipment on a blanket
insurance or would we need to go another route?
> I would make myself available to meet with the appropriate people to discuss this potential purchase.
