**AMENDMENT TO AGREEMENT FOR
PROFESSIONAL ENGINEERING SERVICES**

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and TRW Engineers, Inc., dba TSC Engineering, (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on February 24, 2015, pursuant to SOQ 14-025, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional seventeen thousand eight hundred forty-four dollars and no/100 (\$17,844.00) for the additional drainage revisions as described in the Cost Proposal dated September 21, 2016 attached hereto as Exhibit "A" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed four hundred thirty thousand seventy dollars and 50/100 (\$430,070.50), authorized as follows:
 \$412,226.50 under the Agreement; and
 \$17,844.00 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without subsequent amendment executed by the parties.
4. The Time of Performance under the Agreement shall hereby be extended an additional twelve (12) months and end no later than February 23, 2018.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.

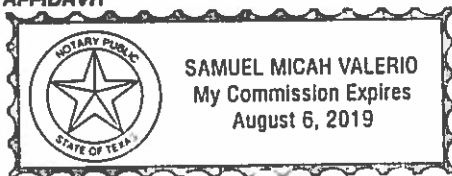
