**AMENDMENT TO AGREEMENT FOR
PROFESSIONAL ENGINEERING SERVICES**

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and IDS Engineering Group, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on July 7, 2015, (hereinafter "Agreement") for Services to be provided under the Fort Bend County 2007 Mobility Bond Program – SH 99 at Harlem Road U-Turns and Left Turn Lanes – Project No. X27 pursuant to SOQ 07-080; and

WHEREAS, the parties desire to amend the Agreement to add Construction Phase Services to be rendered by Contractor and increase the total Maximum Compensation available to perform the additional Services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. Services to be rendered under the Agreement shall be amended to add Construction Phase Services, as described in the Man Hour Estimate for Construction Phase Services attached as Exhibit "A" and incorporated herein for all purposes.
2. County shall pay Contractor an additional forty thousand seven hundred sixty dollars and no/100 (\$40,760.00) to render Services as described in Exhibit "A".
3. The Maximum Compensation payable to Contractor for Services rendered under the Agreement and this Amendment is hereby increased to three hundred twenty-four thousand sixty dollars and no/100 (\$324,060.00), authorized as follows:


\$283,300.00 under the Agreement; and
\$40,760.00 under this Amendment.
4. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written amendment executed by the parties.
5. The Time of Performance for Contractor to complete all Services under the Agreement and this Amendment is hereby extended by an additional twelve (12) months for a total of thirty-six (36) months from the date of Contractor's initial receipt of the Notice to Proceed under the Agreement.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.




