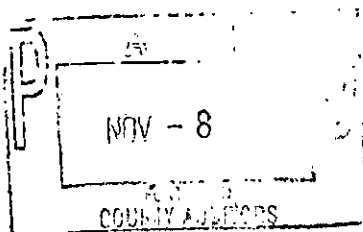

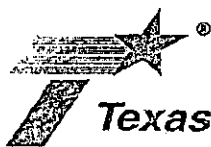
Commissioner Meyers stated the Grand Parkway Toll Road Authority will reimburse the County a portion of the costs.

Commissioner Patterson stated the project started as a TXDOT project to widen Harlem Road. The Grand Parkway Toll Road will handle the U-Turn projects.

The subject project is scheduled for construction letting on November 3 or 4, 2016. Per the terms of the funding agreement between the Texas Department of Transportation (TxDOT) and Fort Bend County (County), TxDOT agreed to notify the County of the amount of funds payable by the County to TxDOT for this project prior to letting.

The project is funded under the Category 12 Strategic Priority program. Per the original agreement the funding is 80 percent Federal and 20 percent State with a maximum amount payable of \$600,000.00. The County is responsible for paying for all items in excess of the Federal and State participation.

The attached cost calculation worksheet details the funding responsibilities for the projects. The County's cost participation is \$1,438,394.50. Thus, the total owed by the County is \$1,438,394.50.

Please consider this letter as your notification that a payment of \$1,438,394.50 is now due and payable to TxDOT for the County's funding participation for this project.

We request that you expedite the payment. We will be unable to award a construction contract to the low bidder for the project if we do not have the County's financial participation.

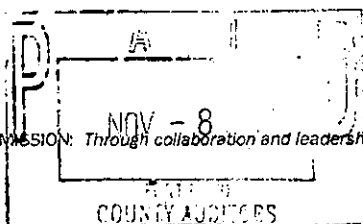
