 - "Compensation for performance of services within the Scope of Services described in Attachment A shall be in accordance with the billing rates shown in Attachment B, with total compensation not to exceed \$95,000.00. Payments for work detailed in Attachment A will be made as such work is performed."
- 3. The first paragraph of Section 3 is replaced with the following paragraph:
 - "It is understood and agreed that the time for performance of the Engineer's services under this Agreement shall begin with receipt of the Notice to Proceed and end May 31, 2017."

This Supplemental Agreement does not alter, modify, or otherwise change any part of the Agreement, except as specifically stated in this Supplemental Agreement.
