

**SUPPLEMENTAL AGREEMENT NO. 2
TO
AGREEMENT OF JANUARY 21, 2015
FOR
ENGINEERING SERVICES for
Fort Bend Parkway Toll Road (SH 6 Crossing)**

This Supplemental Agreement is made and entered into this 19th day of April, 2017, and modifies the ENGINEERING SERVICES AGREEMENT with Geotest Engineering, Inc., dated January 21, 2015, for engineering services for the Fort Bend County Toll Road Authority.

The agreement is hereby modified as follows:

1. The first sentence of Section 2.a is replaced with the following sentence:

“The Maximum Compensation under this contract is \$295,400.00.”

2. The second paragraph of Section 2.a is replaced with the following paragraph:

“Compensation for performance of services within the Scope of Services described in Attachment A shall be in accordance with the billing rates shown in Attachment B. The compensation was increased by \$5,400.00, for the work shown in Attachment A. The maximum amount payable under this agreement shall not exceed \$295,400.00. Payments for work detailed in Attachment A will be made as such work is performed.”


This Supplemental Agreement does not alter, modify, or otherwise change any part of the Agreement, except as specifically stated in this Supplemental Agreement.



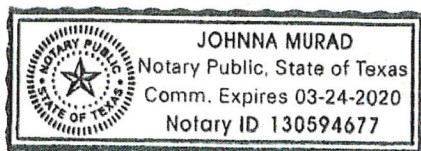
