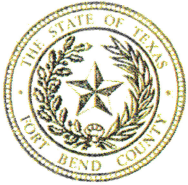

Mary Fishburn is requesting a waiver of penalty and interest for the 2016 tax year, stating she mailed her check to our office on January 17, 2017 from her neighborhood mailbox. She also mailed Sienna Plantation MUD & LID checks on the same day and were received on time.

Tax Office Records Indicate:

- November 7, 2016 - The Original 2016 Tax Statement was mailed to Mary V Fishburn, 2858 Five Oaks Dr., Missouri City, TX 77459-6504. **This statement was not returned by the Post Office.**
- February 6, 2017 – Received payment of \$4,107.58 with post marked date February 2, 2016.
- February 17, 2017 - 2016 Reminder Notice was mailed to Mary V Fishburn, 2858 Five Oaks Dr., Missouri City, TX 77459-6504. **This statement was not returned by the Post Office.**
- February 20, 2017 – Short Notice mailed for additional \$287.53 due by March 9, 2017 to receive original post marked date.

- February 22, 2017 – Mary Fishburn called in regards to the additional amount due and stating that she mailed her other two checks for the Sienna Plantation MUD & LID on the same day and they were received on time. The Clerk emailed her a copy of the envelope showing the postmarked date of February 2, 2017; however she does not believe the post marked date is correct when she mailed it on January 17, 2017. Then she went online and paid the remaining \$287.53 by E-check.
- There is no evidence of an error by the Fort Bend County Tax Office or Fort Bend Central Appraisal District.
- Fort Bend ISD has authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty, interest and collection fees and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.

I am writing to you per the advice of the Fort Bend County Tax Assessor Office. I recently received a past due invoice for my property taxes in the amount of \$287.53. I wish to request a waiver of penalty and interest for the following reasons.

I mailed the check on Jan. 17, 2017. I have attached my receipt in which I wrote the date of which I issued the check (1/16/17) and I mailed it the next day. Although I realize this is only my word, as evidence I have also attached my other two tax receipts from the Sienna Plantation L.I.D. and Sienna Plantation M.U.D. which I also mailed the same day with the Fort Bend County tax check, and were received on time. The checks are in succession, and I have attached my cancelled checks from the L.I.D. and M.U.D which show they were received and processed on 1/30/17.


I have also enclosed the Fort Bend County Tax check in question, as well as the envelope with the postmark Feb. 02, 2017. The check was posted 2/06/17 in the amount of \$4,107.58.

I mailed all three of these checks on the same day, from my neighborhood mailbox. I do not understand why it took so long for these checks to be received, thereby causing my Fort Bend Cty. tax check to be delinquent. I had no reason to hold this particular check or not mail it when I said I did. When I received the past due invoice on Feb. 21, 2017, it had already accrued more interest. I paid this past due amount via e-check on Feb. 22, and have included my receipt. I will never again use the U.S. Post office box in my neighborhood to mail these checks.

I humbly ask that you waive this amount since my check was technically received only 2 days late due to no fault of my own, even though the other checks were received on time. This amount is a lot of money for me as I save all year to pay my property taxes on time, and have never received a past due invoice in my nearly 15 years at this residence.
