The County has received your request to waive penalty and interest on Fort Bend County property taxes. Fort Bend County is also authorized to act on behalf of the City of Missouri City, Houston Community College Missouri City, Fort Bend Independent School District and Public Improvement District #2 which represents a total amount of \$607.33 for penalties assessed on the referenced account for tax year 2016. Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. Hardik Desai is requesting waiver of penalty and interest for 2016 tax year, stating that he opted out escrowing his taxes with his new mortgage company after refinancing in December 2016, and that he never received a tax statement from our office after doing so.

Tax Office Records Indicate:

• November 2016 – The Tax Office received an electronic request for the 2016 Tax Statement. This was requested by Central Loan Administration. Our office sent this statement electronically in November, 2016. Per Tax Code Section 31.01 (i-1) If an assessor mails a tax bill under subsection (a) or delivers a tax bill by electronic means under subsection (k) to a mortgagee of a property, the assessor is not required to mail or deliver by electronic means a copy of the bill to any mortgagor under the mortgage or to the mortgagor's authorized agent.

- February 17, 2017 2016 Reminder Notice was sent, mailed to: Desai Hardik Vimaleshbhai & Aditi S at 4003 Brindisi Ct, Missouri City, TX 77459-6979 for the amount due of \$8675.97. This statement was not returned by the Post Office.
- February 23, 2017 Received e-check payment for \$9,283.30. This amount includes February penalty & interest.
- City Of Missouri City, Houston Community College Missouri City, PID #2 Assessment, & Fort Bend ISD have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.


