Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011\*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. However, if you have any new information showing proof of an error that was not researched by the Tax Assessor and wish to discuss, please contact your Commissioner, Grady Prestage, prior to May 2, 2017, at telephone 281-403-8000 or by email at james.prestage@fortbendcountytx.gov, to discuss any additional documentation you may wish to provide to the Court when they consider your request.

- February 17, 2017 2016 Reminder Notice was mailed to Ashanth Jacob, 7023 Brewster Ln., Missouri City, TX 77459-1743 and was not returned by the Post Office.
- February 27, 2017 Mr. Jacob called the tax office asking about original tax statement he
  did not receive and to have penalty and interest waived. Was advised to email tax office
  requesting the previous owners email be removed and given the waiver instructions. Mr.
  Jacob made payment on account in the amount of \$5,632.95 including penalty and
  interest.

- March 7, 2017 Tax Office received request from Mr. Jacob asking to remove email: <u>alcocer23@msn.com</u> from tax account. Request was accepted and changes were made to the account.
- There is evidence of an error by the Fort Bend County Tax Office.
- Fort Bend Independent School District has authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest, and allows the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.
