## AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Earth Engineering, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Engineering Services on January 20, 2016, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation for the completion of such additional services.

## NOW, THEREFORE, the parties do mutually agree as follows:

- 1. County shall pay Contractor an additional two thousand two fifty dollars and 56/100 (\$2,250.56) for final services necessary to complete the project as contemplated under the Agreement.
- 2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed twenty-seven thousand two hundred fifty dollars and 56/100 (\$27,250.56), authorized as follows:

\$25,000.00 under the Agreement; and \$2,250.56 under this Amendment.

- In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without written amendment executed by the parties.
- The parties hereby agree the Agreement and the terms hereunder have remained in effect from January 20, 2016 and shall end no later than May 30, 2017.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.
