Maiphuong Krystina Huynh on behalf of Priority Emergency Room is requesting waiver of penalty and interest for 2013 tax year due to being a new business and learning what forms and taxes need to be filed and paid as well as confusing the MUD taxes with County taxes and payment getting overlooked.

- There is no evidence of an error by the Fort Bend Central Appraisal District or the Fort Bend County Tax Office.

 Katy ISD and Harris F/B ESD #100 has authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.

Dear Judge Hebert,

My name is Maiphuong Huynh and I am a managing member of Priority Emergency Room. I recently paid our 2013 property taxes in the amount of \$28,860.12 which includes \$4230.04 in penalty interest because the original tax amount of \$24,630.08 was due before February 1. The payment has cleared and is posted to our account effective today April 14th.

I am writing to request that you waive all or part of our penalty interest. There are several reasons why I did not make payment on time:

- 1. We are a new business and didn't open until mid January 2013. This is the first year we've had to pay local taxes. We are still learning which government forms and taxes need to be filed and paid.
- 2. We recently paid our MUD taxes in the amount of \$7870.87 this past February. In mid February, we also received an invoice in the amount of \$7466.66 due to Fort Bend County. Since the amounts were so similar, I honestly thought we paid the property taxes when I paid the MUD taxes.
- 3. I honestly didn't know that we owe both MUD and property taxes until I received a call from a collection agency stating that we owe \$28k in property taxes. When I reviewed our records, I note that we had 3 tax statements from Fort Bend County. One tax statement showed we owe \$24,630.08 due before February 1 and was flagged to be paid but unfortunately was only filed and not paid. Another tax statement was sent from fort bend county MUD #35 in February and marked as delinquent with \$7726 due in February and \$7870 due in march. Since the payment was mailed on 2/28, we paid the higher amount of \$7870.87 in good faith because we knew the office wouldn't receive payment the same day which would put us into March. A copy of the cleared check is attached and shows it actually posted March 1st. the third statement was dated 2/13/14 for \$7466.66 and came from Patsy Schultz, Fort Bend County.
- 4. The biggest confusion was that we received 2 statements from Patsy Schultz for Fort Bend County, one in the amount of \$24,630.08 and one in the amount of \$7466.66. The delinquent letter was for the amount of \$7466.66 and dated 2/13. Since I just paid MUD taxes in the amount of \$7870.87 (very close to \$7466) to Fort Bend County, I honestly thought I already paid the delinquent tax statement from Patsy Schultz. It was unknown to me at the time that we owe both MUD and property taxes.

Enclosed are copies of all statements and proof of payments. I hope you can understand why there was confusion. I also hope you can understand that \$4230.04 is a significant amount of money for a small start up business as ours. Therefore, I respectfully request that you waive all or at least part of our penalty interest fees.
