Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. However, if you have any new information showing proof of an error that was not researched by the Tax Assessor and wish to discuss, please contact your Commissioner, Vincent Morales, prior to June 6, 2017, at telephone 281-344-9400 or by email at vincent.moralesjr@fortbendcountytx.gov, to discuss any additional documentation you may wish to provide to the Court when they consider your request.

Syed Moinuddin is requesting a waiver of penalty and interest for the 2016 tax year, stating that he did not receive the 2016 original tax statement, however the 2016 reminder notice was received.

Tax Office Records Indicate:

- November 7, 2016 Tax statement was sent electronically to Bank of America. Per Property Tax Code Section 31.01 (i-l): If an assessor mails a tax bill under subsection (a) or delivers a tax bill by electronic means under subsection (k) to a mortgage of a property, the assessor is not required to mail or deliver by electronic means a copy of the bill to any mortgagor under the mortgage or to the mortgagor's authorized agent.
- The Fort Bend County Tax Office is not notified when a release of lien is filed. It is
 the taxpayer's responsibility to notify the Tax Office that their mortgage company no
 longer services their property account.

- February 17, 2017 Mailed 2016 Reminder Notice to Moinuddin Syed & Fareesa, 2638 Brazos Ridge Dr, Sugar Land TX 77479-8928. This statement was not returned by the Post Office.
- February 23, 2017 The Fort Bend County Tax Office received payment of \$3,705.48 for 2016 taxes (includes February Penalty and Interest).
- There is no evidence that an error was made by the Fort Bend County Tax Office or the Fort Bend Central Appraisal District.
- LCISD and The City of Sugar Land have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on Section 33.011 of the State Property Tax Code.

I Syed & Fareesa Moinuddin are the owner of property at Riverpark Section 3, Block 3, Lot 12. The property address is 2638 Brazos Ridge Drive, Sugar Land, TX 77479-8928. I request you to consider the following facts to waive the penalty I paid on February 23, 2017:

- 1. I received Past Due notice of Property Tax from Fort Bend County Tax Assessor-Collector Office on February 22, 2017.
- 2. I went to the County Tax Office on February 23, 2017 and paid the taxes in full in the amount of \$3,705.48. Without penalty the amount was \$3,463.07. Please see attached.
- My mortgage loan for this property was paid in full as of September 7, 2016. Please see 3. attached letter from the .. This is my first time for payment of Taxes.
- 4. I did not receive an initial letter for the property Tax 2016 from the Bank or Fort Bend County. I came to know about the Property Tax when I received the Past Due Notice.
- However, I received 2016 Tax Statement from Fort Bend County L.I.D. #10 in December 5. 2016. I paid this tax on December 20, 2016 without delay. Please see attached copy of the Statement. But I did not receive Property Tax notice from the Tax Office in December 2016.
- 6. The Bank stated that the Release of Lien notice was sent to Fort Bend County Clerk. Please see attached. The bank said after the loan was paid in full, the Bank is not responsible for Taxes and I should get notice from the County.
- 7. Payment of Property is my responsibility after the loan is paid full. Until September 7. 2016. The Bank was paying the Property Taxes, therefore: I was not aware of the due dates for the taxes. If I would have received the initial Property Tax Notice just like received from LID#10, I would have paid the taxes without fail. In the future, I will look for Property Tax notice in December of each year and pay the tax within the due date. If I do not receive Tax Notice in December of each year, I will call the Tax Office and pay the taxes on time. Therefore, I request you to waive the penalty assessed on my Property Tax for 2016.


