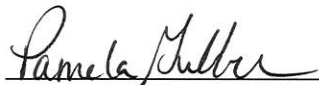

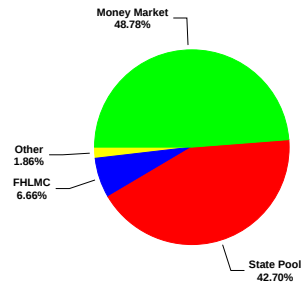

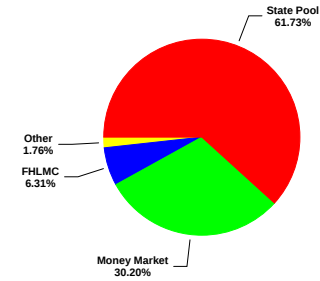

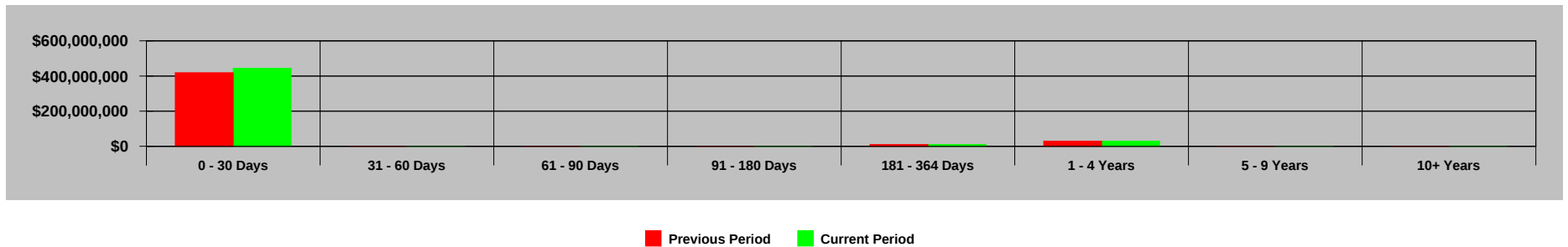
Portfolio Composition - 01/31/17



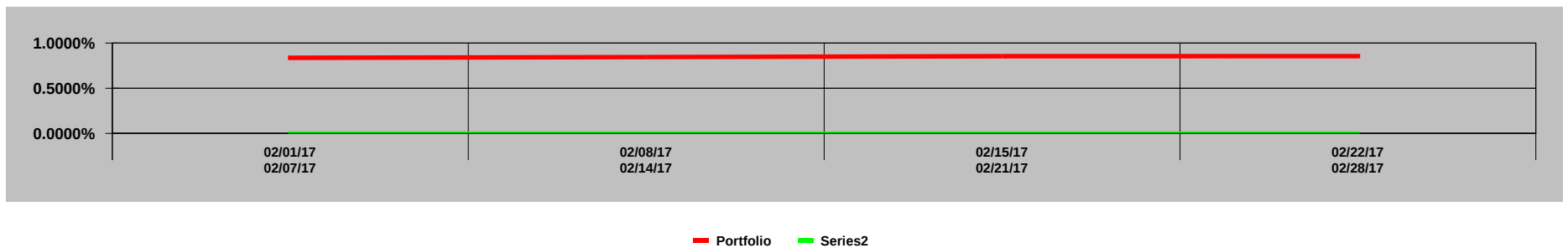
Portfolio Composition - 02/28/17

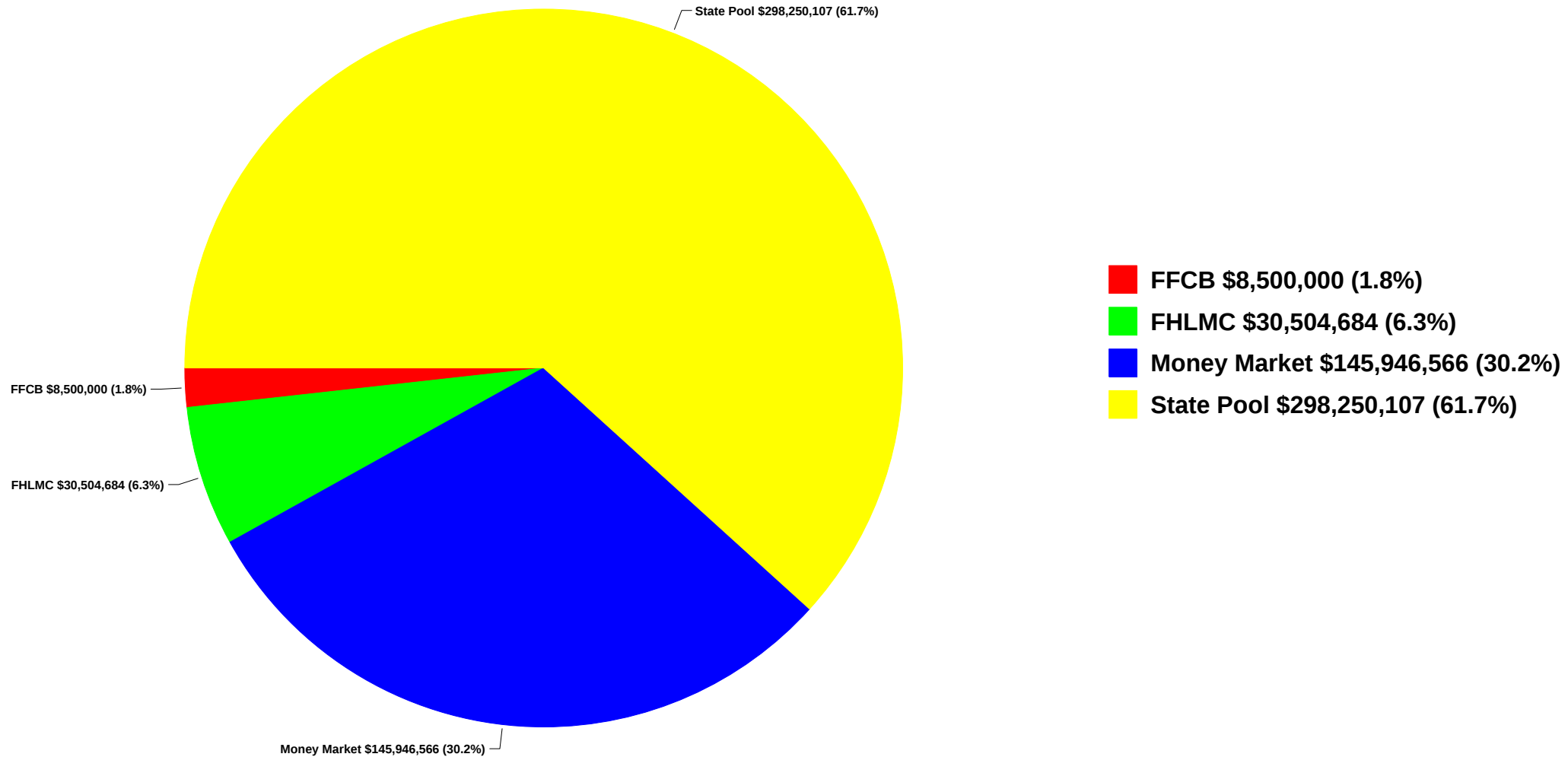

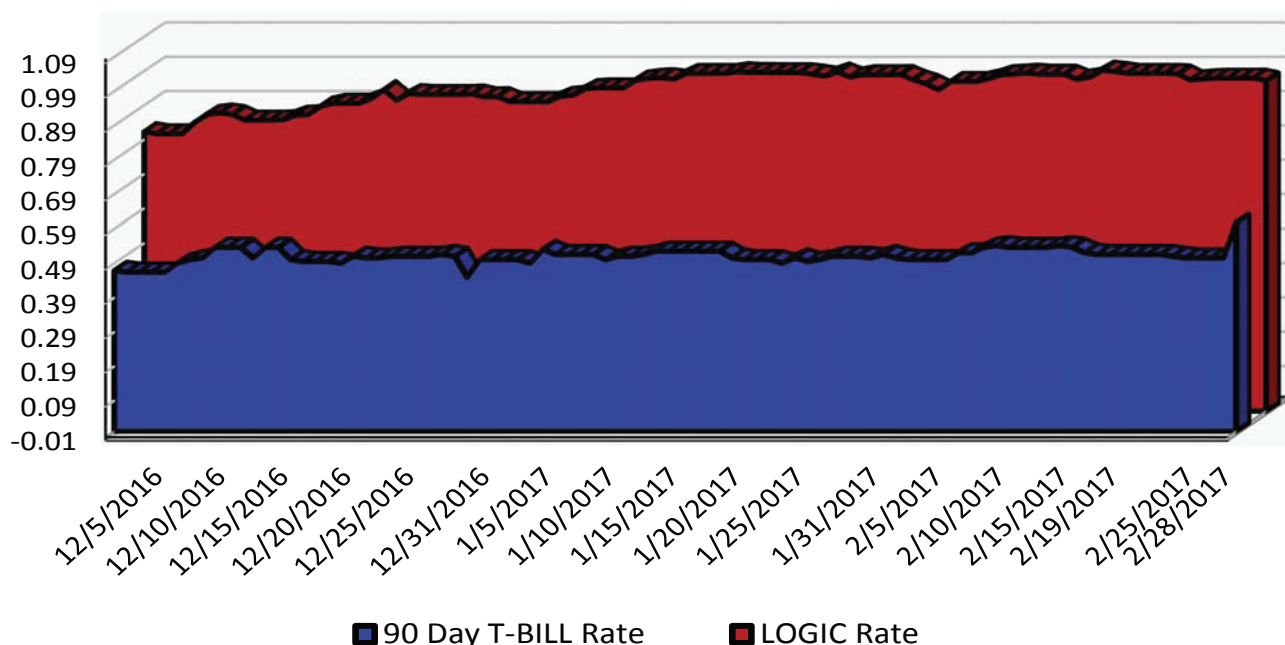
