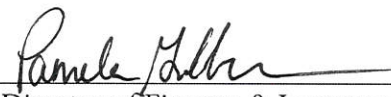

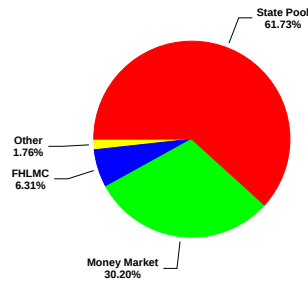

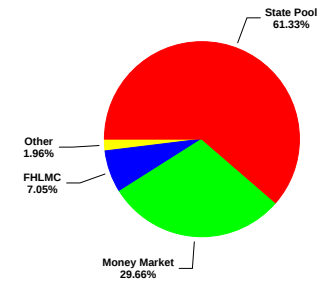

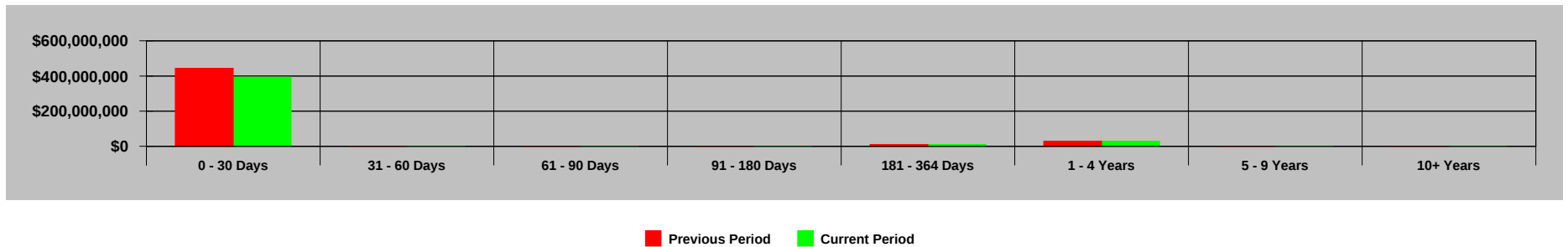
Portfolio Composition - 02/28/17



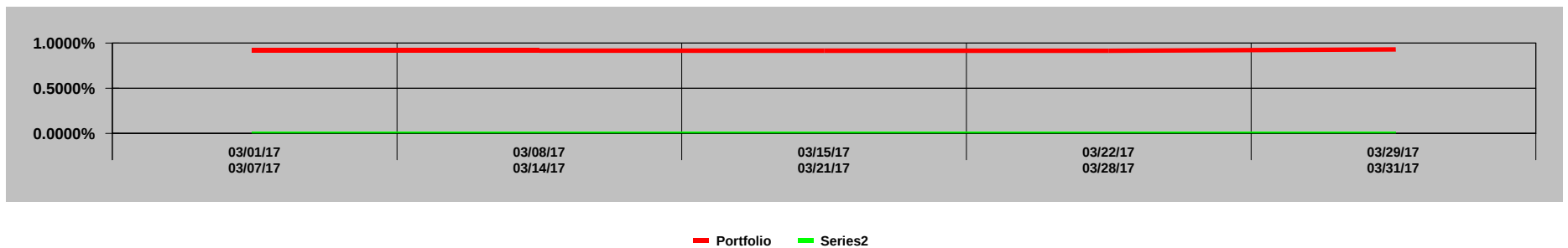
Portfolio Composition - 03/31/17

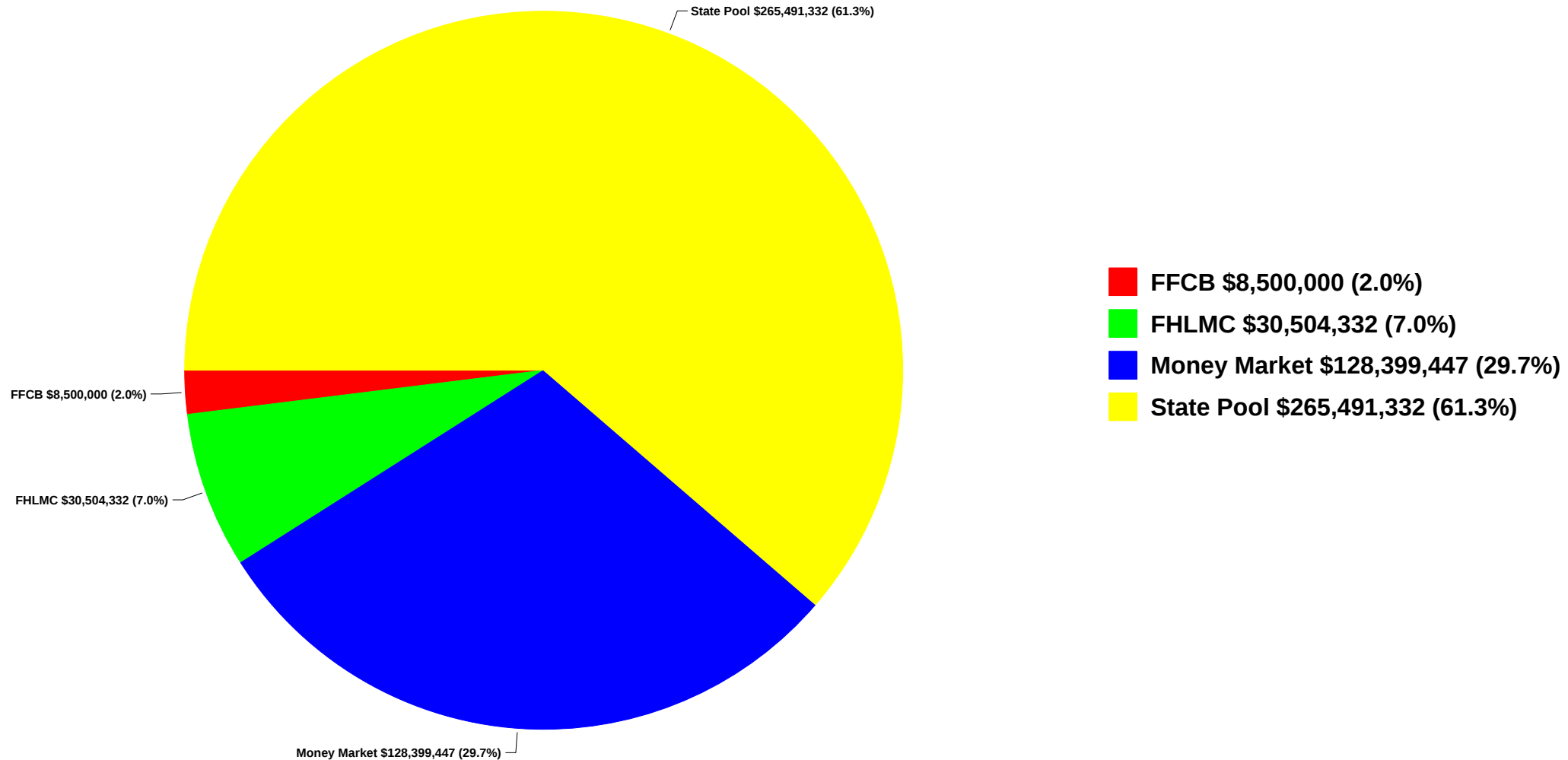

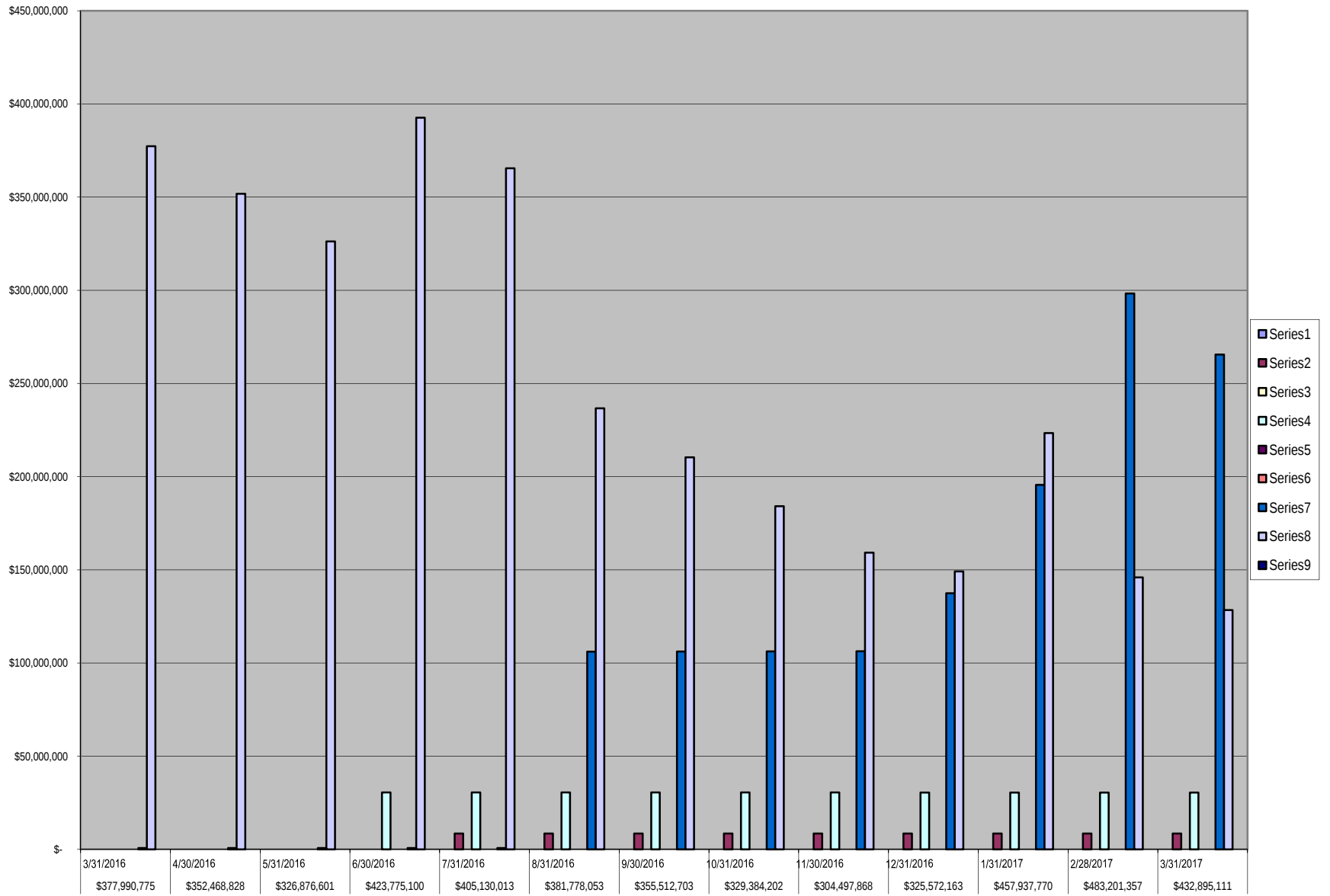

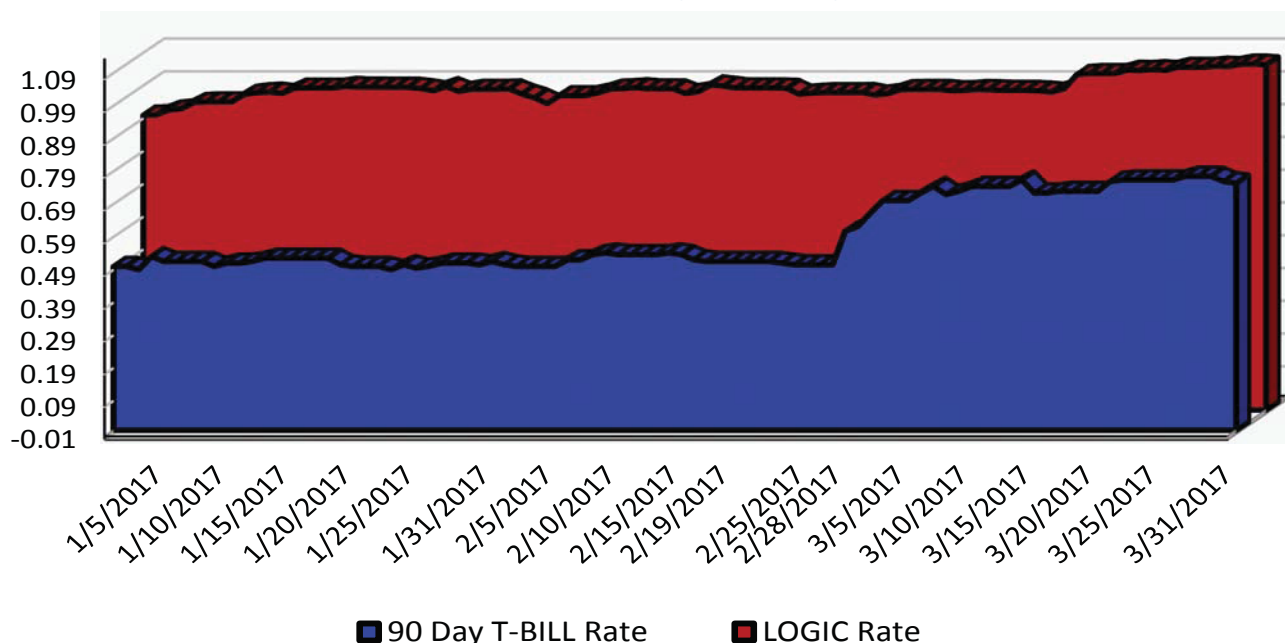
