The County has received your request to waive penalty and interest on Fort Bend County property taxes. Fort Bend County is also authorized to act on behalf of Katy Independent School District, Willow Fork Drainage and Fort Bend Emergency Services District #2 which represents a total amount of \$325.36 for penalties assessed on the referenced account for tax year 2016. The Tax Assessor's Office has conducted research on your account; a copy of the research is enclosed with this letter, and has also been provided to the Commissioners Court.

The information you provided, along with the Tax Office research, has been placed on the Agenda, becoming part of public record, for the Commissioners Court meeting on Tuesday, June 13, 2017 at 1:00 p.m. Commissioners Court is located at the Historic Courthouse, 401 Jackson Street, 2nd Floor, in Richmond, Texas.

You are not required to appear in order for the Court to consider your request. Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. James M. Wade is requesting a waiver of penalty and interest for the 2016 tax year, stating his brother in law mailed the payment in the form of personal check before the due date. Mr. Wade believes the check was stolen from the mail box, allowing access to his personal checking account information causing the check to never arrive to the tax office, and ultimately causing fraudulent activity in his checking account.

Tax Office Records Indicate:

- November 7, 2016 2016 Certified Statement mailed to: James Michael Wade & Van Thi Hong 23242 Dewflower Drive Katy, TX 77494-4246. This statement was not returned by the Post Office.
- February 04, 2017 Received payment from James Michael Wade & Van Thi Hong in the amount \$4,647.90, base levy only.
- February 16, 2017 Short Notice mailed to James Michael Wade & Van Thi Hong 23242 Dewflower Drive Katy, TX 77494-4246. Additional \$325.36 due by 3/6/2017. **This notice was not returned by the Post Office**.

- February 17, 2017 2016 Reminder Notice was mailed to: James Michael Wade & Van Thi Hong 23242 Dewflower Drive Katy, TX 77494-4246. This statement was not returned by the Post Office.
- February 28, 2017 James M. Wade & Van Thi Hong paid the remaining amount due of \$325.36 including February 2017 penalty and interest.
- There is no evidence of an error by the Fort Bend Central Appraisal District or the Fort Bend County Tax Office.
- Katy ISD, Willow Fork Drainage and Fort Bend ESD #2 have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on Section 33.011 of the State Property Tax Code.

Current Status of Taxes

All of the current taxes due for the properties listed are fully paid up, including the penalties that were assessed and this waiver is requested. Evidence that all taxes and penalties have been paid is provided in Attachments A.1, A.2, A.3, A.4 and A.5. It is understood that this is a requirement before this request will be considered.

Basis for Penalty and Interest Waiver Request

The basis for this request is from the Texas Property Code Sec. 33.011 (3) (A) which states:

- '(3) may waive penalties and provide for the waiver of interest on a delinquent tax if the taxpayer submits evidence showing that:
 - (A) The taxpayer attempted to pay the tax before the delinquent date by mail;'

Summary of Events

A brief summary of what occurred is provided below, and where relevant supporting documentation is attached. This evidence demonstrates that my wife and I did attempt to pay all taxes due on time by mail.

I work overseas as a Petroleum Engineer and reside with my wife in Ho Chi Minh City, Vietnam. To pay our 2016 property taxes we prepared checks for each statement we received. The checks were placed in envelopes with postage affixed. My wife's brother was visiting us and hand carried the envelopes with the checks back to Oklahoma City, OK where he resides. Copies of the duplicates for the checks from our check book are shown in Attachment B.

On January 12, 2017 my wife's brother placed the envelopes (there were a total of seven) in his home mailbox for the postman to pick up.

On February 3, 2017 we check our bank account online to make sure the checks had cleared. Upon inspection of our account we discovered there were 4 fraudulent charges on our account. Two of the charges were made with counterfeit checks using our bank account number and 2 of the check numbers from the ones we mailed to pay our property tax. These were to create two electronic charges that were not ours to a Target and Walmart. Two other fake checks that used our account number were cashed at Braum's. All of these businesses were located in Oklahoma City.

We immediately contacted our back and disputed the charges. Affidavits for these claims are provided in Attachments C.1, C.2, C.3 and C.4.

Our back required that our checking account number be immediately taken out of service and new account number was assigned to us. We also put a stop payment on the checks that were mailed to pay our property taxes. A letter from our bank, , is in Attachment D.

We wrote new checks from a different account, and a relative assisted us in mailing these new checks. As stated previously all the taxes have now been paid, along the penalties assessed for late payment which we are requesting to be waived.

In discussing our case with the bank, it was suspected that the checks were stolen from the mail and the account then fraudulently used. They informed us they would contact the police and would fully prosecute anyone that was caught. We have not heard any update on the investigation.

Summary

My wife I did in fact attempt to pay our property taxes on time and in full by mail. Due to apparent theft our checks from the U.S. postal system the original checks never arrived and new checks were issued as soon as we became aware of the problem. This resulted in the payments arriving in February 2017. Under Sec. 33.011 of the Texas Property Code we respectfully request a waiver of the Penalties and Interest as summarized in the Table above.
