## ORDER AUTHORIZING PUBLICATION OF NOTICE OF INTENTION TO ISSUE CERTIFICATES OF OBLIGATION

<u>Section 3</u>. The notice set forth in **Exhibit A** to this Order shall be published once a week for two consecutive weeks in a newspaper of general circulation in the County, the date of the first publication to be before 30 days prior to the date set in said notice for the issuance of Certificates of Obligation.

Section 4. The Commissioners Court, the County Judge, the County Auditor, and the County Clerk, and other officers of the County are hereby authorized and directed to do any and all things necessary or desirable to carry out the provisions of this Order. The County Judge may approve such changes in the attached notice, its publication, or this Order as are consistent with the intent of the Commissioners Court.

<u>Section 5</u>. This Order shall take effect immediately upon its passage.

#### NOTICE OF INTENT

TAKE NOTICE that the Commissioners Court of Fort Bend County, Texas (the "County"), shall convene at 1:00 pm on July 18, 2017, at its regular meeting place at the County Courthouse, 301 Jackson St., Richmond, Texas, of said County and during such meeting, the Commissioners Court will consider the passage of an order authorizing the issuance of certificates of obligation in an amount not to exceed \$60,000,000 for the purpose of paying contractual obligations to be incurred (1) for the purpose of evidencing the indebtedness of the County to pay all or any part of the contractual obligations incurred for the design and construction of road facilities in the County and (2) for professional services. The certificates of obligation will be payable from the levy of an annual ad valorem tax, within the limits prescribed by law, upon all taxable property within the County and from a pledge of net revenues derived from the operation of the County's park system.
