The County has received your request to waive penalty and interest on Fort Bend County property taxes. Fort Bend County is also authorized to act on behalf of Fort Bend Independent School District and Fort Bend Municipal Utility District 134 C which represents a total amount of \$1274.85 for penalties assessed on the referenced account for tax year 2016. You are not required to appear in order for the Court to consider your request. Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011\*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. Joseph Shoboiki is requesting a waiver of penalty and interest for the 2016 tax year, stating the cashier check was mailed at the end of December. but the bank confirmed that the check never got cashed. He discovered this discrepancy when closing the bank account the payment was paid from.

## Tax Office Records Indicate:

- November 7, 2016 The Certified 2016 Tax Statement was mailed to Jayne & Joseph Shoboiki, 17414 Endel Way, Richmond, TX 77407-2764. This statement was not returned by the Post Office
- February 17, 2017 2016 Reminder Notice was mailed to Jayne & Joseph Shoboiki,
   17414 Endel Way, Richmond, TX 77407-2764. This statement was not returned by
   the Post Office

- February 27, 2017 Received payment from Jayne Shoboiki in the amount of \$17,245.33, base levy only.
- March 1, 2017 Short Notice mailed for additional \$1,207.17 due by March 17, 2017 to receive original post marked date. This was not returned by the Post Office
- March 2, 2017 Received Name Change for the Fort Bend Central Apprisal District's office, and 2016 Name/Address Change 2 Tax Statement was mailed to Joseph A Shoboiki Etal, 17414 Endel Way, Richmond, TX 77407-2764. This statement was not returned by the Post Office
- May 31, 2017 Jennifer Shoboiki paid the remaining amount due of \$1,274.85 including May 2017 penalty and interest.
- There is no evidence of an error by the Fort Bend County Tax Office or Fort Bend Central Appraisal District.
- Fort Bend ISD and Fort Bend MUD 134C have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on Section 33.011 of the State Property Tax Code.
