RE: Beechnut Street at Grand Vista Springs Boulevard – Interim Multi-Way Stop Control

Dear Commissioners:

The Fort Bend County Engineering Department has completed a review of the operational conditions at the intersection of Beechnut Street and Grand Vista Springs Boulevard in anticipation of the opening of Fort Bend Independent School District Elementary School No. 50 (James Patterson Elementary School). The posted speed limit on Beechnut Street is 45 mph. The intersection currently operates with stop control on Grand Vista Springs Boulevard. Beechnut Street is identified as a Major Thoroughfare in the 2015 Fort Bend County Major Thoroughfare Plan.

A traffic signal will be constructed at the intersection and is scheduled to be operational when the widening of Beechnut Street is completed. In the interim, Engineering recommends conversion of the intersection to multi-way stop control until the signal is operational, as shown on the attached traffic control plan. The public hearing date for acceptance of the plans will be scheduled on the next available Commissioner's Court Agenda. 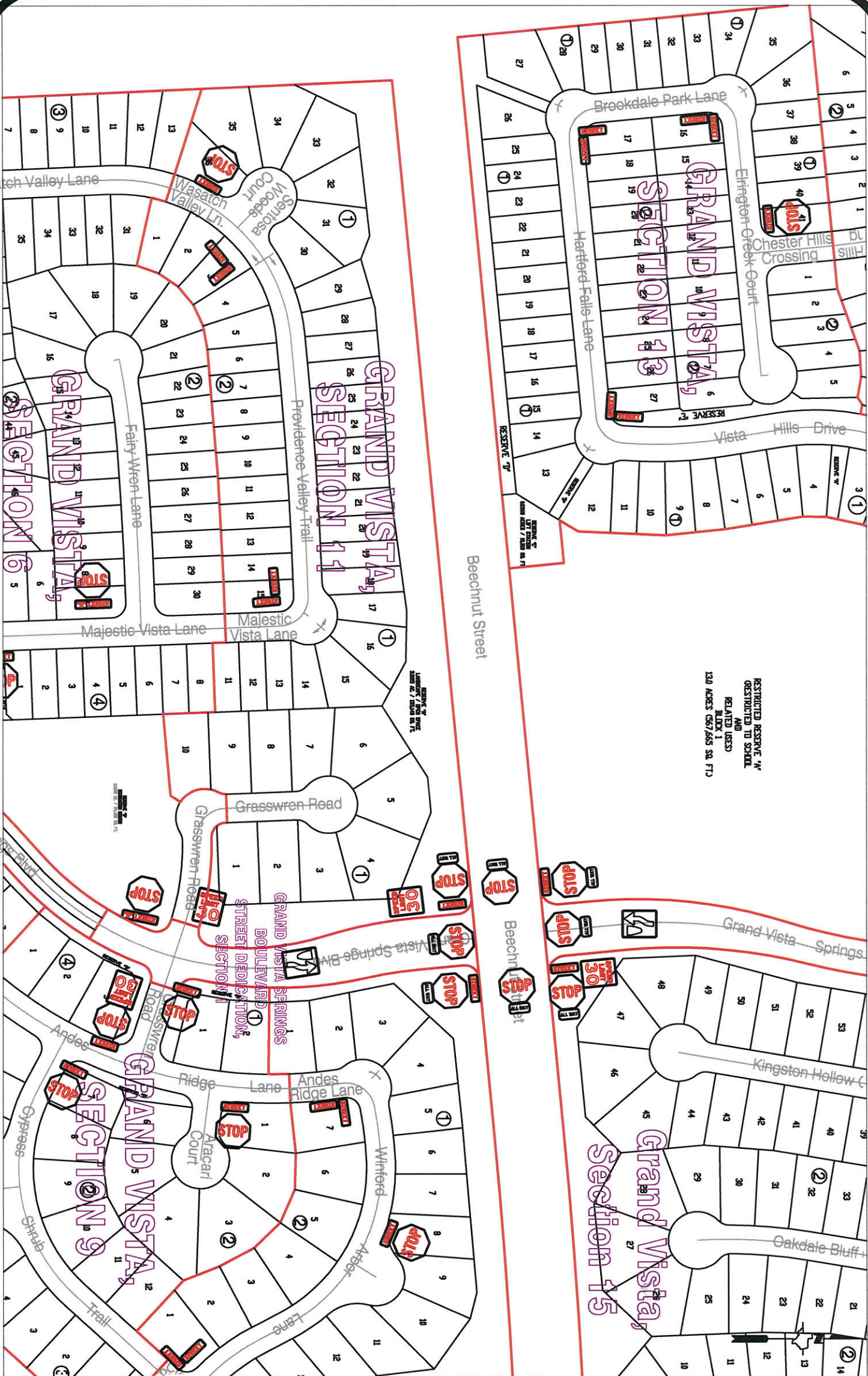
