AMENDMENT TO AGREEMENT FOR PROFESSIONAL CONSTRUCTION MANAGEMENT SERVICES

THIS AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and AECOM Technical Services, Inc., (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Professional Construction Management Services on August 23, 2016 pursuant to SOQ 14-025, (hereinafter "Agreement"); and

WHEREAS, the parties desire to amend the Agreement for additional services to be provided and increase the total Maximum Compensation for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional four hundred seventy thousand dollars and no/100 (\$470,000.00) for additional construction management services for the additional 2013 Mobility Bond projects in Precinct 3, allocated as follows:

2. The Maximum Compensation payable to Contractor for Services rendered is hereby increased to an amount not to exceed six hundred twenty-six thousand eight hundred dollars and 00/100 (\$626,800.00), authorized as follows:

\$156,800.00 under the Agreement; and \$470,000.00 under this Amendment.

3. In no case shall the amount paid by the County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without further written agreement.

Except as provided herein, the parties agree that all terms and conditions of the Agreement shall remain unchanged.
