TRAFFIC CONTROL NARRATIVE FOR CULVERT APPLICATION (APP-14912)

The permit application seeks to have a culvert installed for a residence at 1802 Fox Trot Circle. Driveway from the residence is to be perpendicular to Fox Trot Circle, and a culvert is required to clear the drainage ditch on the west side of the property. HOA requirements state that culvert is to have sloped ends at a 30 degree angle.

While work is going on, and until we have a driveway in place (which cannot happen until a culvert is set), workers will either park in the property as long as the ditch is not holding water and they are able to drive through it. Otherwise, they will park on the east side of Fox Trot Circle - allowing for traffic to pass on the west side of the street.

There will be no parking along Blue Grass Drive, as that is a major thoroughfare for the subdivision. Fox Trot Circle is a cul-de-sac and is less traveled. Workers will maintain a passable lane on Fox Trot for residence and daily traffic.
