# SUPPLEMENTAL AGREEMENT NO. 3 TO AGREEMENT OF July 26, 2016 FOR

### ENGINEERING SERVICES AGREEMENT for Fort Bend Grand Parkway Toll Road, Segment D, Brazos River Erosion Study

This Supplemental Agreement is made and entered into this 19<sup>th</sup> day of July, 2017, and modifies the ENGINEERING SERVICES AGREEMENT made with Freese and Nichols, Inc., dated July 26, 2016 for the study of the Brazos River erosion at Segment D, as amended.

The agreement is hereby modified as follows:

- 1. The first sentence of Section 2.a is replaced with the following sentence:
  - "The Maximum Compensation under this contract is \$689,767.25."
- 2. The second paragraph of Section 2.a is replaced with the following paragraph:
  - "Compensation for performance of services within the Scope of Services described in Attachment A, and Exhibit A-1 thru A-3 shall be in accordance with the billing rates shown in Attachment B. The compensation for additional services described in Exhibit A-3 is billed hourly and not to exceed \$30,000.00 as shown in Exhibit B-3. Payments for work detailed in Attachment A and Exhibit A-1 thru A-3 will be made as such work is performed."
- 3. The Scope of Services shown in Attachment A shall be expanded to include Exhibit A-3, attached hereto.
- 4. The Compensation for Scope of Services shown in Attachment B shall be expanded to include Exhibit B-3, attached hereto.
- 5. Section 3 is replaced with the following paragraph:
  - "It is understood and agreed that the time for performance of the Engineer's services under this Agreement shall begin with receipt of the Notice to Proceed and end January 31, 2018."

This Supplemental Agreement does not alter, modify, or otherwise change any part of the Agreement, except as specifically stated in this Supplemental Agreement.

### **EXHIBIT A-3**

### SERVICES TO BE PROVIDED BY THE ENGINEER

The work to be performed by the Engineer under this Supplemental Work Authorization consists of providing engineering services for shop drawing review and engineering assistance to the FBGPTRA related to the construction phase of the SH 99 Brazos River Drilled Shaft Wall project.

### **Construction Phase Services**

The Engineer shall provide Construction Phase Services at the written request of the FBGPTRA project manager. The written request shall include a description of the work requested, a mutually agreed upon time limit, and any special instructions for coordination and submittal. These services shall include, but are not limited to the following:

### 1. Shop Drawing Review

The Engineer shall review and approve shop drawings prepared and submitted by the contractor or fabricator of materials and work related to the construction of the project.

<u>Distribution of Shop Drawings</u>: The FBGPTRA shall forward to the Engineer for review and approval, the shop drawings submitted by the Contractor. The Engineer shall have a maximum of 7 business days from receipt of the shop drawings to review, approve, stamp and return the shop drawings to the FBGPTRA. This time may be decreased to a lesser and mutually agreeable time limit if the FBGPTRA feels it is necessary in order to avoid delay of construction activities. The Engineer shall return the submission to the FBGPTRA. The FBGPTRA shall distribute the returned review documents to the Contractor or Fabricator.

### 2. Construction Assistance

The Engineer shall assist the FBGPTRA on an as needed basis during the duration of the construction phase of the above referenced projects. As requested by the FBGPTRA, the Engineer shall provide assistance as follows:

- Participate in weekly project status meetings.
- Review change orders.
- Attend site visits.
- Respond to Requests For Information (RFIs).
- Provide minor redesign and/or modeling.
- Answer general questions about engineering design basis.
- Provide clarification for Construction Package plan set drawings.

### 3. Additional Project Related Tasks

The Engineer shall provide other project related tasks in support of the FBGPTRA during construction, as requested by FBGPTRA. Engineer shall provide a mutually agreed upon time and an estimate of anticipated work effort necessary for completion of each task requested. All additional project related tasks will be compensated in accordance with Exhibit B-3, Compensation.
