THIS AMENDMENT is made by and between the State of Texas, acting through the Texas Department of Transportation, called the "State" and Fort Bend County, called the "Subrecipient".

WITNESSETH

WHEREAS, the State and the Subrecipient executed a project grant agreement on Oct 25 2017 12:32PM; and,

WHEREAS, it has become necessary to amend that project grant agreement;

NOW THEREFORE, the State and the Subrecipient do agree as follows:

AGREEMENT

1. Description of Amended Items

This amendment revises the project budget by transferring \$1,070 from Third Party Contract Capital Cost of Contracting ALI 11.71.12 to Acquisition - Acquisitioned Hardware ALI 11.42.07, \$560 from Third Party Contract Capital Cost of Contracting ALI 11.71.12 to Acquisition - Acquisitioned Software ALI 11.42.08, \$642 from Third Party Contract Capital Cost of Contracting ALI 11.71.12 to Acquisition - Miscellaneous Equipment ALI 11.42.20, \$400 from Third Party Contract Capital Cost of Contracting ALI 11.71.12 to Purchase Signage ALI 11.92.08, and \$10,266 from Third Party Contract Capital Cost of Contracting ALI 11.71.12 to Operating ALI 30.09.01. Attachment B, Project Budget, hereto attached, shall replace the Project Budget page in said agreement.

All other provisions of the original project grant agreement not amended are unchanged and remain in full force and effect. This amendment becomes effective on the later date of full execution by both parties.

2. Incorporation of Master Grant Agreement (MGA) Provisions

This amendment incorporates all of the governing provisions of the MGA in effect on the date of final execution of this amendment, unless an exception has been made by the terms of this PGA.

3. Signatory Warranty
