Information Requested:

It is apparent that pay item #21 for concrete driveways is incorrect with a quantity of 3960 SY when there is only 3274 SY of roadway paving on the entire job. This quantity is close as a SF quantity for the 21 driveways. If bid at SY this would have been $3960 \times $45 = $178,200$ (adding over \$150k to our bid total). This item was bid at the \$5.00 price $\times 3960 = $19,800$ (which is the correct total for all the driveway paving).

Since this bid item quantity and unit are incorrect, we request that this item be deleted and a new item be added by change order. The correct bid item will be $440 \text{ SY} \times \$45.00 = \$19,800.00$, since spec 530 says driveways are paid by the SY. This will result in the same contract amount (no increase or decrease) and will correct the mistake on bid item #21.







I know this was an error and \$5/LF is pretty high.

We can make that work and go ahead and solid sod the disturbed area for \$5/sy.

It should only be about 4-5' behind the curbline throughout the project then we can probably eliminate the hydromulch.

You can go ahead and get the Engineer to change this and add it to the change order.

Quantity should end up around 850 SY @ \$5/SY.
