West Sycamore Road (formerly Rabb Rd) from Shadow Haven Drive to Teal Estates Boulevard, and from Teal Estates Boulevard to include the re-alignment of roadway now called West Sycamore Road – adjustments of street lengths for the County Road Log

Dear Commissioner:

The roadway revisions to the County Road Log for Mobility Project #13113 are as follows:

- Rabb Road (change to West Sycamore Road) from Shadow Haven Drive to Teal Bend Blvd. within Teal Run, Sec 4 plat. 190.01 LF (.036 miles)
- Rabb Road (change to West Sycamore Road) from Teal Bend Blvd. to Teal Estates Blvd.
 1,430.00 LF (.27 miles)
- Add: West Sycamore Road (realignment) from Teal Estates Blvd to Eaglewood Trail Dr. 847.80 LF (.16 miles)

NOTE: The portion of Rabb Road and West Sycamore that is being abandoned has been adjusted out with the revisions above.


