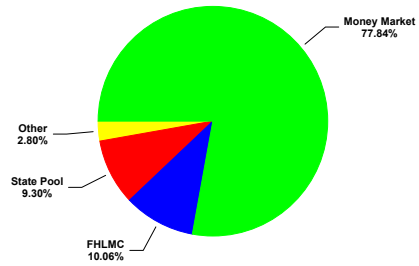

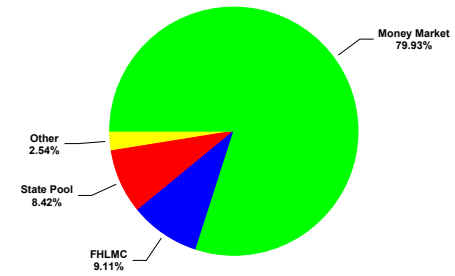

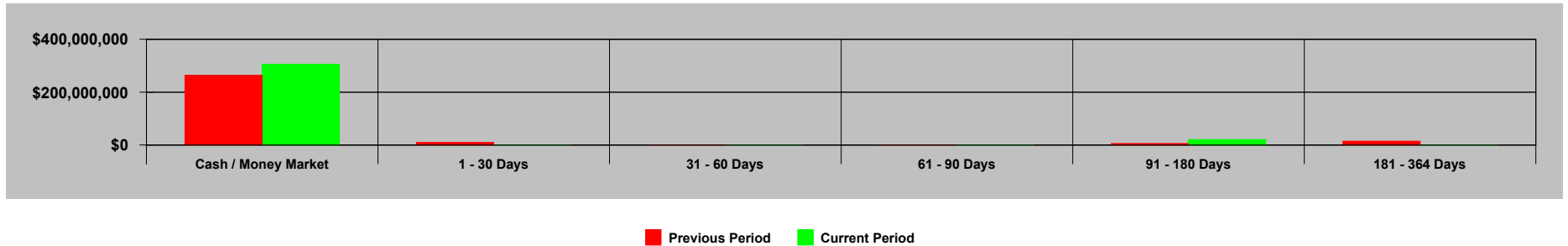
Portfolio Composition - 11/30/17



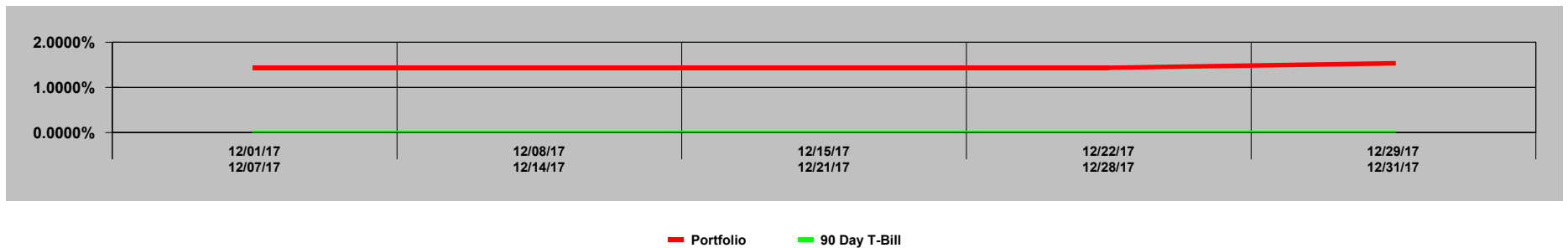
Portfolio Composition - 12/31/17

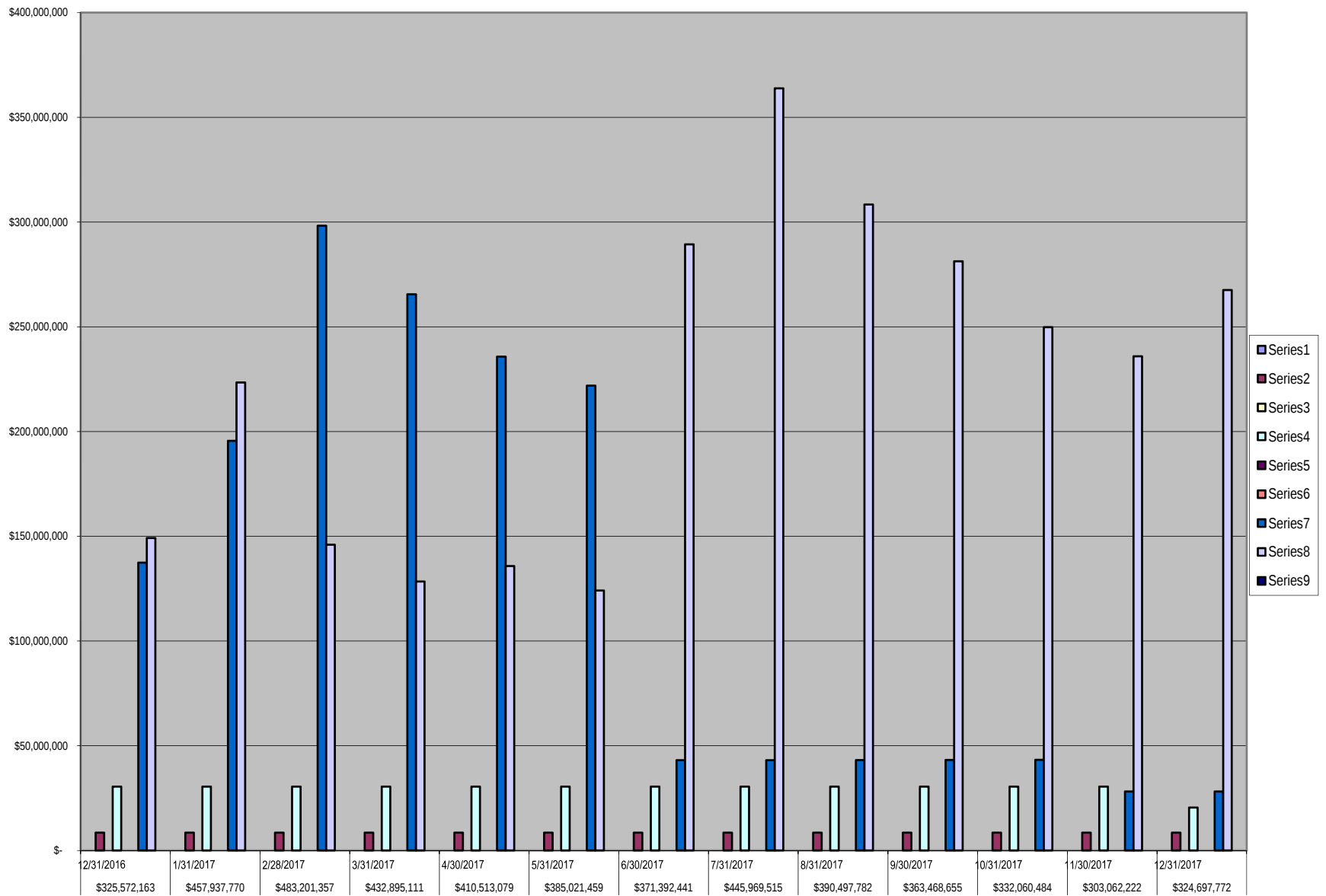

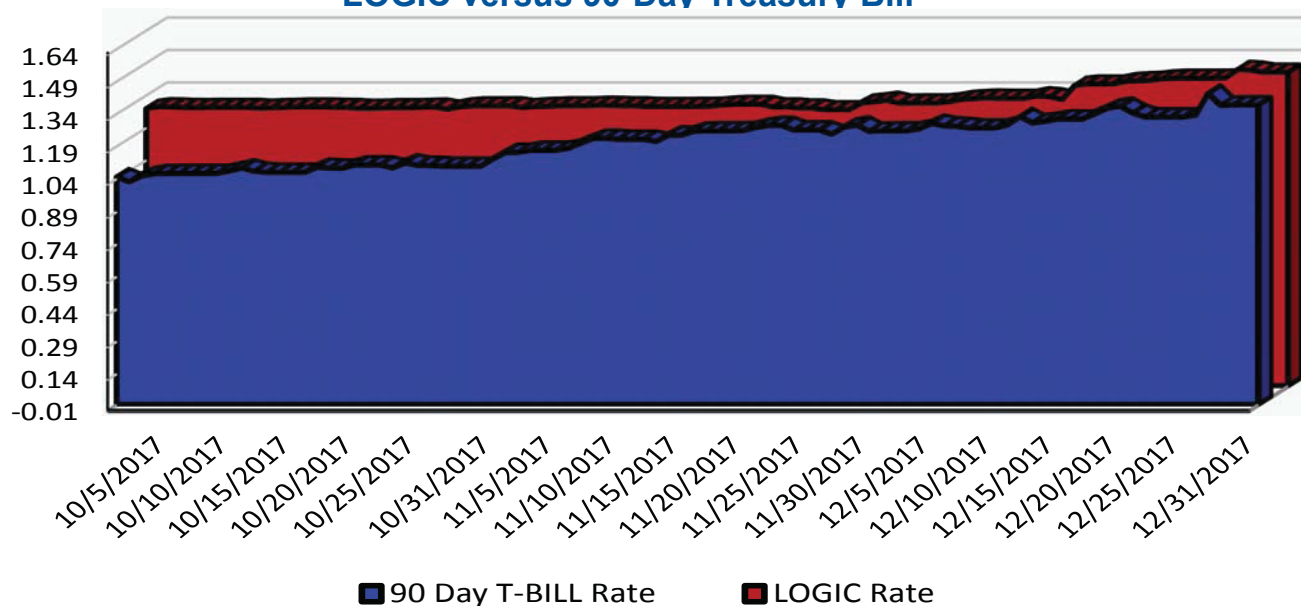
