WHEREAS, the Commissioners Court of Fort Bend County, Texas (“Commissioners Court”), has heretofore appointed the Board of Directors of Fort Bend County Levee Improvement District No. 20 (the “District”) to serve for lawful four-year terms of office expiring August 28, 2019; and

WHEREAS, Scott West, Jeffrey R. Singer, and David Hunter are the currently appointed resident directors of the District, who desire to be reappointed; and

WHEREAS, the Commissioners Court desires to Jared Biermann to serve as a replacement for Scott West for the District for Scott West’s term of office expiring August 28, 2019, or until his successor shall be appointed and qualified; and

WHEREAS, Jared Biermann is over twenty-one years of age, a resident citizens of the State of Texas, is otherwise qualified by law to serve as a Director of the District, and is not disqualified from serving as a Director of the District by reason of any law; and

WHEREAS, Title 4, Chapter 57 of the Texas Water Code, as amended, confers jurisdiction on the County Judge and Commissioners Court of Fort Bend County, Texas to appoint the Directors of the District; Now Therefore,

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED BY THE COUNTY JUDGE AND COMMISSIONERS COURT OF FORT BEND COUNTY, TEXAS THAT:

Section 1: The foregoing recitals are hereby found to be true and correct.

Section 2: Jared Biermann is hereby appointed as Directors of Fort Bend County Levee Improvement District No. 20 to serve in that capacity for the term of office which expires on August 28, 2019, or until his successor shall be appointed and qualified.

Section 3: A copy of the Order shall be recorded in the minutes of this Court.
