Ladies and Gentlemen:

We have served as disclosure counsel to you in connection with the captioned bonds (the "Bonds") issued by Fort Bend County, Texas (the "County") pursuant to an election held within the County on November 5, 2013, an order adopted by the County on January 23, 2018 (the "Order"). Unless otherwise expressly provided herein, capitalized terms used herein shall have the meaning ascribed thereto in the Order.

We have examined originals or copies, certified or otherwise identified to our satisfaction, of such records of the County, agreements, certificates, and documents, and we have satisfied ourselves as to such matters, as we have deemed necessary in order to enable us to express the opinions set forth herein. In particular, we have reviewed the Preliminary Official Statement dated January 13, 2018 (the "Preliminary Official Statement"), and (2) the Official Statement dated January 23, 2018 (the "Official Statement") (collectively, the "Official Statement"). In our examination, we have assumed the authenticity of all documents submitted to us as originals, the conformity to the original of all documents submitted to us as certified or photostatic copies, the authenticity of the originals of such latter documents, and the accuracy of the statements contained in such documents.

As your counsel, we have participated in the preparation of the Official Statement and in conferences with representatives of the County and its counsel, the Underwriters and their counsel, and the financial advisor to the County, at which conferences the contents of the Official Statement and related matters were discussed. The purpose of our professional engagement was not to establish or confirm factual matters set forth in the Official Statement, and we have not undertaken any obligation to verify independently any of such factual matters set forth in the Official Statement and we do not assume any responsibility for the accuracy, completeness, or fairness of the statements contained in the Official Statement. Accordingly, we have, with your knowledge, not conducted any independent due diligence or other factual investigation of any of the persons, entities, parties, events, activities, or conditions (financial,
