Honorable Judge Hebert:

Fort Bend County Engineering Department has received and reviewed a request (letter attached) from Costello, Inc., for Fort Bend County to sponsor a project for a public road connection at FM 723 at Deer Run Meadows Boulevard within Deer Run Meadows Development. The road connection and northbound left turn lane will improve traffic flow along FM 723.

Any and all cost involved with the project will be borne by FBC MUD 200, and KB Home Lone Star, Inc. There will be no cost to Fort Bend County.

The Texas Department of Transportation request that an agency, such as Fort Bend County, act as a sponsor for the project. This means that the permit for the work will be issued in the name of Fort Bend County and the County accepts responsibility for the terms and conditions of the permit.

We recommend acceptance of the sponsorship and request that this item be placed on the 6/5/2018 Commissioner's Court agenda. We have prepared a letter to Texas Department of Transportation, for the County Judges' signature.


