The County has received your request to waive penalty and interest on Fort Bend County property taxes. You are not required to appear in order for the Court to consider your request. Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. However, if you have any new information showing proof of an error that was not researched by the Tax Assessor and wish to discuss, please contact your Commissioner, James Patterson, prior to June 12, 2018, at telephone 281-980-2235 or by email at james.patterson@fortbendcountytx.gov, to discuss any additional documentation you may wish to provide to the Court when they consider your request.

Rajesh Danayak is requesting waiver of penalty and interest for 2017 tax year, stating that his bank returned his online bill payment he submitted due to incorrect address.

Tax Office Records and Research Indicate:

- November 27, 2017 2017 Original Tax Statement was mailed to: Danayak Rajeash & Radha, 14827 Horse Creek Ln.; Sugar Land, TX 77498-7059 -- was not returned by the Post Office.
- February 7, 2018 Mr. Danayak called our office stating his online bill payment was returned by his bank due to incorrect address.
- February 9, 2018 Tax Office received 2017 tax payment from Mr. Danayak in the amount of \$4,054.07 including penalty and interest.

- There is no evidence of an error by the Fort Bend Central Appraisal District or the Fort Bend County Tax Office.
- Fort Bend ISD and Fort Bend ESD #5 have authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on Section 33.011 of the State Property Tax Code.

Hello,

Based on my conversation with Patsy Schultz office on February 7, 2018 I am writing this letter towards your attention and consideration. This in reference to the above property.

Like every year, I sent my tax payment in the amount of \$3788.84 through my bank, which was scheduled to be delivered on-time on January 30, 2018 with no penalty. This was addressed to Patsy Schultz, PO Box 1028, Payment process Center, Sugar Land, TX 77487-1028 as given on the tax statement. Also, Attachment 2 shows the payee address, amount and delivery date from my bank for Patsy Schultz.

On February 7, 2018, my bank notified me through email (see Attachment 1) that this payment was sent back due to incorrect address. Upon getting this email, I right away contacted the bank to send me the copy of check, which was mailed, the Bank responded that they destroy the mails after it is returned because of non-delivery (see Attachment 3).

I contacted the Fort bend County Tax office immediately and faxed all the required information in this matter. They realized the issue and advised me to write to you to get the penalty (in the amount of \$265.23) to be waived. I have maintained good record of paying every tax on time for the last 17 years. Due to several job losses, this year was tough but I still was able to send the payment on time but unfortunate above defined incident happened.

I am really not sure what happened and strongly feel that I should not be penalized for this as I have abided by the rules and request your kind consideration. I have learned my lesson this year and in the future, I will make sure to deliver payment way before the deadline to prevent any such untoward mistakes described from happening by any party including me, post office, bank and many more.
