RESOLUTION GIVING APPROVAL TO A PROJECT FOR HARMONY PUBLIC SCHOOLS

WHEREAS, the Industrial Development Authority of the County of La Paz, Arizona (the "Issuer") is a public not-for-profit corporation created pursuant to the provisions of Title 35, Chapter 5, of the Arizona Revised Statutes, as amended (the "Act"), and the Issuer is empowered under the Act to issue bonds to finance educational and housing facilities for open-enrollment charter schools as described in the Act; and

WHEREAS, Charter School Solutions, a Texas nonprofit corporation and 501(c)(3) organization (the "Borrower"), proposes to obtain financing from the Issuer from the proceeds of one or more series of the Issuer's bonds or notes in a maximum principal amount of \$85,000,000 (the "Bonds") to finance the costs of acquiring, constructing, improving, furnishing, and equipping educational facilities for pre-K, primary, and secondary school students of the Borrower's campuses across the State of Texas, including the following Fort Bend County location: 1428 Eldridge Road, Sugar Land, Texas 77478 ("Harmony School of Excellence - Sugar Land"); and

WHEREAS, pursuant to Section 147(f) of the Internal Revenue Code of 1986, as amended, and the Proposed Regulations thereunder (the "Code"), the Issuer has caused to be published a notice of a public hearing with respect to the issuance of the Bonds and the financing and refinancing of the Project, and held such a hearing (the "TEFRA Hearing") on the Project after reasonable notice, on June 7, 2018 at 11:00AM at 600 Travis, Suite 4200, Houston, TX 77002; and

WHEREAS, pursuant to the provisions of Section 147(f) of the Code, the Commissioners Court of Fort Bend County, Texas after the TEFRA Hearing, must approve issuance of the Bonds by the Issuer to enable the Bonds to qualify as tax-exempt obligations under the Code;

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS COURT OF FORT BEND COUNTY, TEXAS:

Section 1. The Commissioners Court, solely for the purposes of Section 147(f) of the Code, hereby approves the proposed issuance of the Bonds by the Issuer for the benefit of the Borrower, in an amount not to exceed \$85,000,000, and the facilities to be financed with proceeds from the Bonds.

Section 2. The foregoing approval is given in accordance with the provision of Section 147(f) of the Code and for no other purposes and is not to be construed as an undertaking by Fort Bend County, Texas. The Bonds shall not constitute a liability, indebtedness, or an obligation of Fort Bend County, Texas nor shall any of the assets of Fort Bend County, Texas be pledged to the payment of the Bonds.

Section 3. This resolution shall take effect immediately from and after its passage and it is accordingly so resolved.
