The following is our status report for the US 90A @ SH 99 project for the period of April 1, 2018 to June 30, 2018:

Work completed during reporting period

- Completed hydraulic and hydrologic analysis and submitted the draft drainage study to TxDOT on June 15, 2018.
- Completed design and development of roadway plan and profile sheets, intersection layouts and all necessary sheets for 60% submittal.
- Completed design and development of retaining wall and sound wall plan profile sheets for 60% submittal
- Completed cross section development
- Completed design storm sewer system layouts and development of drainage area maps and storm sewer plan and profiles.
