- One percent (1%) of the actual construction cost for projects fifty thousand dollars (\$50,000.00) or less, or
- Five hundred dollars for the first \$50,000.00 plus one-half percent (0.5%) of the actual construction cost over \$50,000.00

Total Valuation	Fee
\$50,000.00 and less	One percent (1%) of the actual construction cost of the project.
\$50,000.01 and up	\$500 for the first \$50,000.00 plus one-half percent (0.5%) of the actual construction cost over \$50,000.00.

Plan Review Fee Calculation:

Valuation of Infrastructure Work Covered by Infrastructure Permit: \$66,774

Fee Calculation Per Table:

\$500 per first \$50,000 = \$500

One-Half percent of value for portion over \$50,000 = $\$16,774 \times .005 = \83.87

Total Infrastructure Plan Review Fee: $\$500 + \$83.87 = \$583.87$
