In July, 2018 Fort Bend County Animal Services (FBCAS) had the good fortune to have representatives from Dogs Playing for Life (DPFL) spend 5 days with our shelter dogs, staff and volunteers to help us launch our own playgroup initiative. FBCAS is an open admission municipal shelter with an intake of approximately 3500 pets per year.

In early 2015, with new management in place, the focus of the shelter turned towards developing and implementing life-saving initiatives for our pet population. In January of 2015 our save rate was 58%, in September of 2018, our save rate was 91%. One of the reasons for our increase in our save rate is meeting our goal not to euthanize for time or space, and we house healthy and treatable animals for longer periods of time as a result.

These pets, mostly the "blocky headed whatevers", did not have an outlet for their energy and so they were being overlooked in their kennels. That is changing with the amazing time we spent with Tucker and Rafi from DPFL. Because of their help, we have a dedicated group of volunteers who are our playgroup leaders and staff who are able to lead groups on their own as well.

We have had an incredible change in our kennel environment with the stress levels being reduced, the volunteer base is more engaged, the staff can go out and work with the dogs as a group and we have been able to showcase our playgroups during adoption hours and have dogs adopted right from the group!

We would like to expand the program with the recommendations made by DPFL when they gave us our assessment as well as add a new play area with runs and gates that will allow us to be flexible with the size of the groups coming out. We are also interested in utilizing some of the funding if possible to have a follow-up session with the team from DPFL to continue training staff and volunteers in the program. We anticipate the cost to be \$10,000, all for fencing and installation and we know that it will benefit all of our dogs to help find them a new home.
