Action by the Court is governed by guidelines under Texas Tax Code, Chapter 33, Section 33.011*, Commissioners Court cannot waive penalty, interest and/or collection fees unless there is evidence of an error by the appraisal district or the County. - February 20, 2018 2017 Reminder Notice was mailed to Thomas Jacob & Lally, 5603 Oban Terrace Ln, Sugar Land, TX 77479-4779. This statement was not returned by the Post Office.
- February 27, 2018 Received payment of \$736.98 (including February penalty and interest) from Nickey Thomas.
- There is evidence of an error by the Fort Bend Central Appraisal District. Prior Owners Agent should have been removed from this account.
- Fort Bend ISD has authorized Fort Bend County Tax Office to handle the processing of the waiver of penalty and interest and allow the Fort Bend County Commissioners Court to make the determination based on 33.011 of the State Property Tax Code.


